ANSWERS TO QUESTIONS RECEIVED THROUGH 10:00 AM ON OCTOBER 25, 2018

- Q#1 Pg. 8, Section II. Statement of Qualifications Submittals, (f) "Evidence of Insurance Coverage" references Attachment A, Subsection 9. I believe the correct reference is Attachment A, Article 5. (Also, it appears Articles 2 & 3 are mis-numbered). Attachment A, Article 5.1.B Lists Umbrella/Excess Liability as \$,000,000. Please advise correct amount of coverage.
- A#1 Correct. The RFQ under subsection (f) in Section II. is amended to reference Article 5 of Attachment A, which is also amended to specify the requirement for the Consultant to carry an umbrella/excess liability insurance policy in an amount not less than \$3,000,000.
- Q#2 Does Attachment E, the Affirmation and Disclosure Form for Offshore Services, need to be included in our submission?
- A#2 Yes, Section II. of the RFQ is amended to include a reference to Attachment E in the Statement of Qualifications Submittals.
- Q#3 Does the new initial acceptance date of 11/16/18 affect firms with a December expiration date? If it does, how?
- A#3 The current Statements of Qualifications remain valid and acceptable for use in assigning task orders to those qualified firms through the remainder of the calendar year.
- Q#4 Does accepting applications through 2019 and 2020 mean that there is now rolling renewal overall and/or for new categories?
- A#4 Please submit a response to the RFQ for all categories for which the respondent seeks recognition. The only significance of the "initial acceptance" reference is the recognition that firms that do not submit their statements before the due date are not precluded from submitting later during the biennium.
- Q#5 Will our submission date affect our new expiration date?
- A#5 No.
- Q#6 For personnel listed as project managers and key staff for Item 5: Protective Coatings Inspection, must all individuals be ODOT Certified Coatings Inspectors?

Or is there an equivalent certification that would be acceptable in lieu of an ODOT Coatings Inspector certification?

- A#6 All staff proposed to perform Protective Coatings Inspections shall be ODOT Certified Coatings Inspectors.
- Q#7 Regarding the Umbrella/Excess Liability Insurance Policy mentioned in Attachment A under Article 5 in Section D, what is the minimum amount of primary general liability and automobile liability required?
- A#7 See the response to Q#1.
- Q#8 Are there any EDGE, SBE or MBE goals anticipated with the tasks that would be assigned for ITEM's 1 or 9?
- A#8 There are no goals established for responses to the RFQ.
- Q#9 If the answer to the preceding question is yes, does the firm need to identify any EDGE, SBE or MBE firms they would intend to use in meeting diversity goals on possible projects within their SOQ?
- A#9 No, see above.
- Q#10 Because this is only an SOQ, should firms wait to present diversity involvement information until submitting on individual assignments if required?
- A#10 Correct.
- Q#11 Will identifying a diversity teaming partner in the Firms SOQ be taken in to consideration in scoring or selecting a Firm for a project?
- A#11 No.
