## ANSWERS TO QUESTIONS RECEIVED THROUGH 3:00PM ON OCTOBER 27, 2016:

- Q#1 The total weight of our electronics housing is 19 pounds. Is that acceptable for this bid?
- A#1 Yes, if the sign support is sufficient to hold the load. Accordingly, the paragraph under <u>Housing</u> in General Specifications on page 7a is modified to add the following two sentences:

"The Unit may exceed a total weight of 15 pounds provided the specified support assembly is capable of carrying the load of the Unit proposed. Bidders submitting offers for Units that exceed 15 pounds shall also provide calculations certified by an Ohio Registered Professional Engineer attesting to the capacity of the specified support structure to carry the proposed load."

- Q#2 The operation of our radar speed sign is via a Bluetooth connection only. The software to operate our sign will run on Windows devices and Android devices. Is that acceptable?
- A#2 No. Wireless connectivity is not compatible with the Commission's operating systems.
- Q#3 Our display can show digits (numbers) of 11 inch height. They can easily be read at 400 feet from the sign. Is that acceptable? If any of these variances are not acceptable, could you please let me know why? We would really like the opportunity to bid and provide the Ohio Turnpike Commission a quality radar speed sign that will exceed expectations for many years.
- A#3 No. The locations where the Commission will install the signs require the specified 12-inch display.
