# Q#1 Is there any bridge painting on this project?

A#1 There is bridge painting on this project, but it is limited to touch up painting related to reference items SP 516G and SP 516J, in addition to any currently existing coatings that are damaged during the Contractor's operations

# Q#2 What is the required DBE percentage for the project?

A#2 There are no established DBE goals for this project. However, bidders are required to utilize and demonstrate their Good Faith Efforts to attain the participation of MBE/DBE certified businesses' on the opportunities available under project. The standards for reviewing the bidders' demonstration of its Good Faith Efforts using the forms provided at GFE-1 and GFE-2 are described on pages DBE-1 through DBE-4. This requires identifying the bidders' commitments with MBE/DBE businesses, the opportunities for participation, the availability of MBE/DBE businesses to perform those opportunities, and the actions undertaken to attain MBE/DBE commitments to participate in those opportunities.
