ANSWERS TO QUESTIONS RECEIVED THROUGH 1:00PM ON JUNE 12, 2017:

Q#1 Is there a particular manufacturer and part number for the petroleum tanks that your organization prefers?

A#1 The Commission does not have a preference for a specific tank. The minimum Specifications that the tanks are required to fulfill are described on page 7a and 7b of the Invitation to Bid.

Q#2 Page 1 states “the small business enterprise goal (including SBE, DBE and EDGR) is 0%. However, the bid document includes Small Business Enterprise Participation Certification, Bidder’s SBE Utilization Plan and Demonstration of Good Faith Efforts. If the SBE goal is 0%, are bidder’s still required to complete the SBE documents?

A#2 The SBE goal set forth on the Notice to Bidders for this procurement is 0%. However, all bidders are required to complete and sign the forms on Pages 12a and 12b. Bidders are not required to complete the forms on 12d and 12e regardless of the SBE participation amount described on pages 12a and 12b.

Q#3 When do you anticipate the term of the contract to commence?

*A#3 The Commission will not select a Contractor for award until its August 21, 2017 meeting, and the services under the new contract shall commence on or around September 1, 2017. With this Addendum No. 1, the Commission is **extending the bid opening to June 30, 2017** and the bids received shall remain valid for at least 60 days for selection through a notice of intent to award. See Instructions to Bidders on page 2d and Section 2(B) of the General Terms and Conditions on page 3b. The cover page and notice to bidders is amended accordingly through this Addendum No. 1.*
