



Q#1 With the existing plans including original construction and more recent widening construction adding new beam lines, please advise if all beams are to be included in the painting of this project.

A#1 The Contractor shall clean and paint all superstructure steel, including but not limited to beams, diaphragms, cross frames, connection plates and bearings regardless whether installed during original or widening construction, in accordance with the specifications. The plans from the original construction and all previous repairs, widenings and modifications were provided for the bidders' reference.
