ANSWERS TO QUESTIONS RECEIVED THROUGH 5:00 PM ON APRIL 22, 2019:

Q#1 In Instructions To Bidders section T, if bidders wish to submit alternates to be approved equals we must do so before the bid opening date. Can the information needed by the bid for the alternates be emailed to purchasing@ohioturnpike.org or must this information also be mailed in?

A#1 Emailing the necessary information to the address provided is sufficient.

Q#2 In bidding the different Groups of furnishings, can a bidder only bid one group and write in “no bid” for the rest of the furnishings? Example - bidder only provides pricing on Group I, Item 1 – Armless Stacking Chair, Sled Base Variety.

Q#2 Yes.

Q#3 The bid document says that “The Small Business Enterprise Goal (including SBE, DBE and EDGE) is waived”, does this mean the bidder still is required to fill out the paperwork pertaining to Small Business Enterprise on pages 11a through 11g?

A#3 Identify any subcontractors or suppliers on page 11b and sign page 11a after indicating whether any subcontractors or suppliers will result in certified firms participating in the transaction.

Q#4 Can we get an extension on the bid opening?

A#4 The Commission has received numerous requests to approve proposed equal. To fully evaluate whether the alternatives satisfy the Commission’s specifications and requirements, the bid opening is extended through this Addendum No. 1 on week to May 7, 2019.
