**Q#1** While reviewing the Bid Package there is a discrepancy on Page 6b "Bid Schedule of Prices" it is showing Mahoning Valley and Glacier Hills as the Plaza names. Can you please confirm that #1 is Middle Ridge and #2 is Vermilion Valley?

*A#1 Yes, the Bid Schedule of Prices mistakenly referred to the wrong set of Service Plazas. Through this Addendum No. 1, the Commission revises Page 6b to correctly reference the Service Plazas at issue as Middle Ridge at Ref. No. 1 and Vermilion Valley at Ref. No. 2. All other information on the Bid Schedule are correct and remain unchanged.*
