



**ANSWERS TO QUESTIONS RECEIVED THROUGH 2:00PM ON NOVEMBER 19, 2018:**

**Q#6 I was wondering if the current contracts are referring to the exact job descriptions for the rates of the current services at Elmore and Castalia. (Are there any additions to the new contract job descriptions?)**

*A#6 There are no additions to the scope of services for the Elmore and Castalia locations than what is provided for the rates described in Addendum No. 1.*

**Q#7 For the monthly window cleaning services... Does this mean 1st floor windows only or are the 2nd floor windows being added?**

*A#7 Cleaning the first floor windows is only required as part of the monthly cleaning services. The second floor windows do not need to be cleaned under Bid Invitation No. 4326.*

**Q#8 Are the garage door windows on the daily window cleaning (as needed) or the monthly window cleaning?**

*A#8 Cleaning the garage door windows is only required as part of the monthly cleaning services.*

**Q#9 Do the glass block windows for the sign shop get cleaned on the monthly window cleaning services at Amherst?**

*A#9 No, cleaning the glass block windows for the sign shop is not included under the scope of services described in Bid Invitation No. 4326.*

**Q#10 There is a 2nd floor at Castalia that has a staircase, 2 rooms and a bathroom that is not currently cleaned by contractor... Is that included with the new contract?**

*A#10 No, cleaning the second floor at Castalia is not included within the scope of services described in Bid Invitation No. 4326.*
