Q#1 Am I disqualified for not committing to achieve the MBE/DBE/SBE goal?

A#1 No, however, Bidders must satisfactorily show its Good Faith Efforts to achieve the Goal (page 11d & 11e).

If responses fail to show a commitment (page 11a) and means to achieve the Goal (page 11b), Bidders must satisfactorily demonstrate their necessary and reasonable actions that, by their scope, intensity, and appropriateness, would reasonably be expected to attain participation that meets or exceeds the Goal (“Good Faith Efforts”). Satisfactory demonstration Good Faith Efforts considers the Opportunities, Availability, Efforts and Commitments to achieve the Goal Bidders document using page 11d & 11e as follows:

Opportunities: On this project, the Commission identified the following (while others may exist):

- A. Material Supply
- B. Trucking/Hauling
- C. Maintenance of Traffic
- D. Labor
- E. Any others the Bidder can identify

Availability: Bidders must show how they searched out firms to fulfill any Opportunities, which may include using the Opportunities as search terms in following certified business directories:

The evaluation of the Bidder’s failure to achieve the Goal applies the relevant factors to make a reasoned determination on whether the Bidder demonstrated a Good Faith Effort.
