ANSWERS TO QUESTIONS RECEIVED THROUGH 4:00 PM ON JULY 11, 2017:

- Q#6 What is the basis for the 3% SBE participation goal? Subcontracting this service is not a viable business practice as there is only one component to the work, which requires trucks specialized for perforing the removal and disposal service.
- Q#6 The Commission has reevaluated the goal, and decided to waive the minimum participation. Accordingly, the Notice to Bidders is modified through this Addendum No. 3 to provide that:

"The Small Business Enterprise Goal (including DBE and EDGE) is 3% waived."

Bidders must still complete and sign Pages 12a and 12b to indicate the amount of any SBE participation included in the bid, but are not required to complete Pages 12d and 12e regardless of the participation amount.

- Q#7 If we travel 1 hour to a site then are only on that site for ½ hour, we have lost money. To make the contract viable it needs to have one cost for being on site with a 1-hour minimum and a second line for the transportation of waste at an hourly rate.
- A#7 Bid Items 4, 5 and 6 contain billables Service and Drive time. The rate of payment per 'Service' hour will be initiated upon arriving at the first site of the day, and will terminate upon leaving the last site of the day. There is no minimum, however it's highly unlikely that mutually agreed upon scheduled runs will result in Service billables being less than 1-hour. The Drive time billable is the actual drive time from the Contractor's facility (or staging location) and the site, and allows for 0.5 hour variance from the expected drive time computed using Google maps.

Items 1, 2 and 3 are exclusively based on gallons, but provide for guaranteed minimums resulting from each service call that should provide the certainty requested.

- Q#8 The testing requirements and financial responsibility for performing those tests appear different than previous bid. Please explain the change.
- A#8 The Commission will provide the test results specified for Bid Items 2, 4 and 5. If the Contractor's disposal facility requires additional testing results, the Contractor is required to obtain those testing results at its expense and include those costs in its bid price. If the regulatory requirements change during the term of the agreement, the Commission may reimbuse the Contractor for the additional expense, without markup, upon a satisfactorly showing that the increase was impossible to anticipate at the time of bid opening.

With this Addendum No. 3, the Commission is further extending the bid opening to 2:00 P.M. (EASTERN TIME) on JULY 14 21, 2017
