ANSWERS TO QUESTIONS RECEIVED THROUGH 5:00 PM ON MARCH 7, 2019:

- Q#1 We are registered with the EPA but through the state of Indiana, not through Ohio. Will that be a problem?
- A#1 Per Addendum No. 2 an EPA Permit number is not required and the applicable language has been revised.
- Q#2 Do we need bed liners? It says the material can't leak but I'm not sure what the consistency of the product is.
- A#2 The native soil in the region of Ohio where the site is situated is a primarily sandy mixture of soil and has been resting atop an impermeable liner for several years while being remediated. Additionally, the Commission will take reasonable precautions to avoid mixing the soil with any standing water in the vicinity of the soil stockpiles. Beyond these facts, and due to the potential for variable weather at the time of hauling, the Commission cannot guarantee its level of saturation will be such that liquids will not leach from the soil. The vendor must use the appropriate means to reasonably ensure that hauled soil does not escape from the truck while the material is in its possession.
- Q#3 Also confirming that the Small Business Enterprise Goal is being waived for this bid.
- Q#3 Correct. We ask that bidders disclose any subcontractors you plan to use on the Utilization Form (OEI-2) regardless whether they are certified business but otherwise the remainder of the OEI forms can be marked NA.
- Q#4 When we are hauling on the Turnpike are we still required to pay our tolls or will this be covered by the bid?
- A#4 The invitation to bid is revised through this Addendum No. 3 to provide for the toll-free use of the Turnpike while solely performing the required services for the Commission under the contract. The Commission will issue transponders for toll-free access to the vendor upon approved request. The vendor shall keep a current record of the transponders to each of its operators, which record shall be made available to the Commission upon request. The failure to return any transponder to the Commission upon demand shall result in a \$100.00 (per transponder) replacement cost charged to the vendor.
