



**Q#11** The bid weight was changed from 296,600 lbs. to 295,900 lbs. in Addendum No. 1. The Bid Form, sheet 6b, still shows 296,600 lbs. and this sheet was never revised. Should we write in the unit price and extended total price using the weight on the form of 296,600 lbs. or write in the new bid weight of 295,900 lbs. and calculate off of that. I don't want my bid to be thrown out over a technicality, so I am just double checking.

*A#11 Correct, the revised quantity was not carried through to the Bid Form. Through this Addendum No. 4, the enclosed modified Page 6b of the Bid Form is substituted for the schedule of quantities originally included in the Invitation to Bid. The Commission will use the revised quantity for bid evaluation purposes.*
