Q#1 I would like to request a copy of the current contract that is in place including pricing and scope of work.

A#1 The current contract and its pricing adjusted through its First Addendum are attached to this Q&A Response.

Q#2 How did you hear about our firm?

A#2 The Commission sent the RFP directly to firms that have previously registered their interest in opportunities of this nature with its procurement department.

Q#3 How long have you been with your current provider?

A#3 The Commission's current provider has performed mobile drug and alcohol testing services since 2012.

Q#4 What is the probability you will change providers?

A#4 As a public entity, the Commission makes its contracting opportunities publicly available on a periodic basis. Whether the incumbent provider will retain the Commission's business is unforeseen, and depends on the proposals submitted and the results of the evaluation process described in PART XI of the RFP.

Q#5 What Laboratory are you currently working with?

A#5 MedTox Laboratories of St. Paul, Minnesota.

Q#6 Who is your current Third party Administrator?

A#6 The Commission does not have a third party administrator to manage its drug and alcohol testing program. The Commission's staff will administer the contract for mobile drug and alcohol testing services resulting from the RFP.

Q#7 What is your current pricing?

A#7 See the response to Q#1.

Q#8 Please list your current collection sites/mobile collectors.

A#8 See the response to Q#1, and the locations identified in the RFP at PART IV and on map at Attachment 1.

Q#9 What panel/drugs are you requesting for the Non-DOT panel?

A#9 It is the same as the 5-panel DOT, which contains amphetamines, marijuana, cocaine, opiates and phencyclidine. Non-DOT panel is for employees in the Toll Operations Department.

Q#10 I am submitting GFE-1 and GFE-2 as requested in the RFP for Mobile Drug and Alcohol Testing Services; however, is this required since we are a certified business enterprise? Please advise.

A#10 Even if the respondent is certified as an MBE, SBE, FBE, WBE, DBE or EDGE firm, it must submit the Good Faith Effort documentation showing its efforts to achieve additional participation or explaining the reasons why additional participation is not practical for this particular opportunity.

**FIRST ADDENDUM TO THE AGREEMENT FOR
MOBILE DRUG TESTING SERVICES BETWEEN

This First Addendum to the Contract, executed August 1, 2012 ("the 2012 Contract"), by and between the *Ohio Turnpike and Infrastructure Commission* fka the Ohio Turnpike Commission (the "Commission"), 682 Prospect Street, Berea, Ohio 44017, and *Safety Controls Technology, Inc.* (the "Selected Contractor"), ~~5075 Taylor Drive, Suite D, Bedford Heights, Ohio 44128~~, is entered into this 1 day of August, 2014. 6993 Pearl Rd

RECITALS

WHEREAS, the Commission entered into the 2012 Contract with the Selected Contractor to provide mobile drug testing services for the Commission; and

WHEREAS, the 2012 Contract had an initial term of two (2) years commencing on August 1, 2012, with the Commission possessing an option to extend the 2012 Contract for an additional term of two (2) years; and

WHEREAS, the Selected Contractor expressed an interest in the renewal of the 2012 Contract for an additional two (2) year term, and proposed modifications to its rates of payment based on fuel price increases, rising laboratory testing fees, and increased labor costs; and

WHEREAS, the Commission and the Selected Contractor successfully negotiated mutually agreeable modifications to the testing rates and desire to enter into an addendum to the 2012 Contract extending its term for the additional two (2) year renewal period and incorporating the modified pricing terms.

NOW, THEREFORE, in consideration of the above and the mutual promises set forth below, the Commission and the Selected Contractor, by way of this First Addendum, hereby make the following agreed to amendments and modifications to the 2012 Contract:

FIRST ADDENDUM

I. ADDENDING THE AGREEMENT – The parties, with this First Addendum, hereby amend the 2012 Contract, with the mutually agreed to modifications set forth below that shall become effective with full execution of this First Addendum.

II. MODIFICATIONS TO THE AGREEMENT – Except to the extent that the 2012 Contract is specifically modified pursuant to this First Addendum, which, upon becoming effective, shall be fully incorporated into the 2012 Contract as if fully rewritten therein, all terms, conditions, and covenants of the 2012 Contract shall remain effective and enforceable against the parties. Unless otherwise indicated, numbered and lettered Articles set forth below correspond to those in the 2012 Contract. Deletions are represented by ~~struck through~~ text, and additions are depicted using **bold** print.

ARTICLE 2 – DESCRIPTION OF CONTRACT AND TERM - For the purpose of exercising the Commission’s option to renew the 2012 Contract for an additional two (2) year period, the following sentence is added to the end of Section 2.1:

“Effective upon execution of the First Addendum, the terms of the 2012 Contract, as modified, shall extend from August 1, 2014, and continue in full force and effect through July 31, 2016.”

ARTICLE 3 – PAYMENTS – For the purpose of incorporating the modified rates of payment for the mobile drug testing services provided by the Selected Contractor during the renewal term of the 2012 Contract, Section 3.1 is restated and modified as follows:

“3.1 Payments to the Selected Drug Testing Contractor shall be made in accordance with PART XVII, Section E of the RFP and the Selected Contractor’s Rates Submission, which is incorporated by reference herein, except Items 1, 2 and 5, which are modified as follows where appearing throughout the Rates Submission:

The Selected Contractor may invoice the Commission \$70.00, rather than \$65.00, for each DOT and Non-DOT drug panel test administered at any location west of Milepost 61, including the Toll Plazas at Exit 59, Exit 52, Exit 39, Exit 34, Exit 25, Exit 13 and Exit 2, or the Swanton (Milepost 48.3) and Kunkle (Milepost 16) Maintenance Buildings, and receive reimbursement for any reasonable lodging expenses incurred when performing mobile drug testing services at the aforementioned western locations.

**FORM CONTRACT
MOBILE DRUG TESTING SERVICES**

This Contract is made and entered into on the 11th day of July, 2012, by and between the **OHIO TURNPIKE COMMISSION** (the "Commission"), 682 Prospect Street, Berea, Ohio 44017, and **SAFETY CONTROLS TECHNOLOGY, INC.** (the "Selected Drug Testing Contractor"), 5075 Taylor Drive, Suite D, Bedford Heights, Ohio 44128.

RECITALS

WHEREAS, the Commission conducted a Request for Proposal ("RFP") process to select a Drug Testing Contractor as more fully described in the RFP; and

WHEREAS, the Selected Drug Testing Contractor submitted the Proposal deemed by the Commission deemed to be a good combination of service value and price; and

WHEREAS, the Selected Drug Testing Contractor is qualified and willing to provide the mobile drug testing services as outlined in the RFP, which is incorporated by reference as if fully rewritten herein, but which, due to its length, is not attached hereto.

NOW THEREFORE, in consideration of the mutual promises, covenants and terms and conditions set forth in the RFP and the Selected Drug Testing Contractor's Proposal, the parties have entered into this Contract.

AGREEMENTS

ARTICLE 1 – CONTRACT DOCUMENTS

1.1 The Contract Documents shall consist of the following documents: The Form Contract; the RFP and any Exhibits thereto; the Selected Drug Testing Contractor's Proposal; and all

insurance certificates and bonds to be provided by the Selected Drug Testing Contractor in accordance with the requirements of the **PART XVII, Section Q** of the RFP.

ARTICLE 2 – DESCRIPTION OF CONTRACT AND TERM

2.1 Subject to the terms and conditions hereof and the “Contract Documents” as defined herein, the Commission shall designate **SAFETY CONTROLS TECHNOLOGY, INC.** as its Drug Testing Contractor.

Subject to the Terminations provisions set forth at **PART XVII, Section P**, the Contract shall have an initial term of twenty-four (24) months with an option to renew the Contract for an additional twenty-four (24) month period, pursuant to the same terms and conditions with any mutually agreed upon modifications. The Selected Drug Testing Contractor will be required to give 120 days advance written notice to the Commission in the event it does not intend to renew the Contract for an additional term.

ARTICLE 3 – PAYMENTS

3.1 Payments to the Selected Drug Testing Contractor shall be made in accordance with **PART XVII, Section E** of the RFP and the Selected Contractor’s Rates Submission, which is incorporated by reference herein.

ARTICLE 4 – ENTIRE CONTRACT

4.1 The Contract Documents embody the entire understanding of the Commission and the Selected Drug Testing Contractor and form the basis of the Contract between the Commission

and the Selected Contractor. The Contract Documents shall be considered to be incorporated by reference into this Form Contract as if fully rewritten herein.

4.2 The Contract and any modifications, amendments or alterations thereto shall be governed, construed and enforced by and under the laws of the State of Ohio.

4.3 If any term or provision of the Contract, or the application thereof to any Person or circumstance, is finally determined, to be invalid or unenforceable by a court of competent jurisdiction, the remainder of the Contract or the application of such term or provision to other Persons or circumstances, shall not be affected thereby, and each term and provision of the Contract shall be valid and enforced to the fullest extent permitted by law.

4.4 The Contract shall be binding on the Selected Drug Testing Contractor and the Commission, their successors and assigns, in respect to all respective covenants and obligations contained in the Contract Documents, but the Contract may not be assigned by the Selected Contractor without the prior written consent of the Commission.

ARTICLE 5 - EXECUTION

5.1 The Contract shall become binding and effective upon execution by the Commission.

ARTICLE 6 – ORIGINAL CONTRACT FORMS

6.1 This Form Contract has been executed in several counterparts, each of which shall constitute a complete original Form Contract that may be introduced in evidence or used for any other purpose without production of any other counterparts.

ARTICLE 7 - WARRANTY OF SIGNATORIES

7.1 The undersigned signatories for the parties hereby represents and warrants that each has full and complete authority to execute the Contract on behalf of their respective parties. This representation and warranty is made for the purpose of inducing the parties to execute the Contract.

ARTICLE 8 – NOTICE

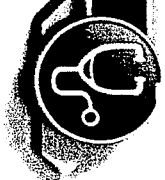

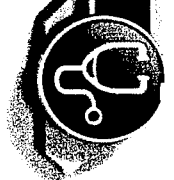

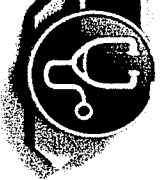
