The adjuster should provide claim updates as needed and currently valued loss runs to the Commission no less than once a month.
- Q#7 Is the Ohio Turnpike Commission self insured?
- A#7 The Commission has a \$100,000 self-insured retention (SIR) for General Liability, Employment Practices and Automobile Liability bodily injury claims. Automobile Liability property damage claims have a \$50,000 SIR.
