Repair of bridge components, including, but not limited to: patching deteriorated concrete; rehabilitation and/or replacing expansion joints; refurbishing bridge deck; performing concrete weatherproofing; preparation and painting of structural steel, maintenance of traffic; and all other items incidental to the completion of the Work. All Work is to be performed as per the Plans,
