Sealed Bids will be received by the Ohio Turnpike and Infrastructure Commission (“Commission”) from Bidders subscribing to Bid Express (<https://www.bidexpress.com>) and selecting the following Project for Bidding:

Bids are to be submitted in accordance with the Contract Documents prepared by the Commission.

Prevailing Wage Rates and Equal Employment Opportunity requirements are applicable to this Project.

All Bidders entering into a Contract on a Commission-administered Project and their Subcontractors will be required to be enrolled, and in good standing in a “Drug-Free Safety Program” approved by the Ohio Bureau of Workers’ Compensation.

Pollution Liability Insurance is required under GC Art. 12.1.4 for this Project. Builder’s Risk Insurance is not required under GC Art. 12.2 for this Project.

Bids will be received for Project No. 59-15-02, which includes the following:

Removal by milling of two (2) inches of existing asphalt pavement in the center lane and right lane of the mainline, mill and fill of the Sonic Nap Alert Pattern (“SNAPs”) in the left shoulder (median), mill and fill select locations on the right (outside) shoulder, resurfacing of the pavement and shoulder to the thickness specified in the Drawings, repair of median catch basins, full depth repairs, approach slab repairs, concrete weatherproofing of bridges, longitudinal joint repairs, installation of raised pavement markers and permanent pavement striping and/or other pavement markings, installation of SNAPs and temporary traffic control, Eastbound and Westbound from Milepost 72.00 to Milepost 86.20. All

Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, and other Contract Documents for Project No. 59-15-02.

Bids will be accepted until **February 6, 2015, at 2:00 P.M (E.S.T.)**, when all Bids will be accessed, opened and read aloud. To avoid a potential extension of the Bid Opening date and/or a potential rejection of all Bids, it is imperative that Bidders submit all questions in a timely manner and no later than seven (7) days prior to Bid Opening.
