- Q#6 ERG is specified in Groups III & IV. Please consider their Florin Cluster Roundabout for approval as furniture specified in Group I Outdoor Furniture and their Napoli Table in Group II Food Court Tables for Group II Food Court Tables.
- A#6 The Florin Cluster Outdoor Table <u>is rejected as an approved equal</u> because it fails to meet the Specifications of Group I, Items 1 and 2, Outdoor Tables, for the following reasons:
  - i. The finish does not meet Specifications.
  - ii. No additional material Specifications provided for review.

The Napoli Series Table is rejected as an approved equal because it fails to meet the Specifications of Group II, Items 1 and 2, Food Court Tables, for the following reasons:

- i. No reference to the bullnose material and/or finish.
- ii. Not enough information provided to determine compliance with the table top Specifications.
- Q#7 Please let me know if you can accept the equal: Proposed equal for Group VI see below and attached Understanding this item varies from look and design but still want to know if this is an option For 'Group VI' we have the attached 55 gallon receptacle, liner and below lid: Below are the color options for thermoplastic (receptacle):
- A#7 The RT-32 trash receptacle, liner and lid is rejected as an approved equal because it fails to meet the specifications of Group VI, Outdoor Trash Receptacle for the following reason:
  - i. Does not possess the replaceable side panels, side opening doors and slide out bag holder.
- Q#8 Please let me know if you can accept the equal: Attached is the closest match for 'Group I' of the bid. As you can see from the specs on page 6 the table top and frame is slightly larger and higher than what the bid asks for This table can come with all 4 seats along with the 3-seat ADA version and both can be surface mounted. The planking will come in a thermoplastic coating which is higher quality and the frame will come powder coated.
- A#8 See response to Q#1 provided in Addendum No. 2. The Extra Heavy Duty Table (230) from Ultra Site is accepted as an approved equal because it meets the Specifications for Group I, Items 1 and 2, Outdoor Tables.

- Q#9 Please let me know if you can accept the equal: Group V We have the attached receptacle, liner and lid. Below are the color options for thermoplastic (receptacle):
- A#9 The DT-32 trash receptacle, liner and lid is rejected as an approved equal because it fails to meet the Specifications of Group V, Item 1 for the following reason:
  - i. Not for indoor application or no detachable lid.
- Q#10 Please let me know if you can accept the option: Proposed equal for Group VII see below and attached. Understanding design is different but would like to know if this is an option. At this time we do not have a cigarette receptacle that has a covered top which is what is being specified but is this a option?
- A#10 The PR-12 Cigarette Butt Receptacle is rejected as an approved equal because it fails to meet the Specifications for Group VII for the following reason:
  - i. Does not meet the capacity or the covered top design Specifications.
