

ANSWERS TO QUESTIONS RECEIVED THROUGH 2:00 P.M., AUGUST 21, 2014:

Q#3 I'm bidding two chassis lines. Is separate bid packets with (1) bid bond to cover the highest amount acceptable?

A#3 Yes. See the Instructions to Bidders at Section D on page 2c. Bidders that are capable of furnishing more than one (1) product that meets the Commission's specifications for a given item may submit more than one (1) bid for the item, and the Bid Guaranty shall be in an amount equal to ten percent (10%) of the highest Bid and the Performance Bond shall be in an amount equal to fifty percent (50%) of the highest Bid. Bidders submitting more than one (1) Bid for any Group shall complete a separate Bid Form incorporating the alternate product that meets Specifications.

Sealed Bids for furnishing to the Ohio Turnpike and Infrastructure Commission, five (5) each current model truck cab and chassis, 48,000 lb. GVWR and furnishing and installing five (5) dump bodies, front plows, wing plows, central hydraulic systems and lighting systems, will be received in the office of the Procurement Manager at the principal office of the Commission, Ohio Turnpike Administration Building, 682 Prospect Street, Berea, Ohio 44017, until 2:00 P.M. (E.D.T.), August 22 September 5, 2014.

At said hour all Bids will be publicly opened and read

The General Terms and Conditions, Specifications, Special Provisions, Bid, Affidavit, Contract and Performance Bond are on file and available to any interested person in the aforesaid Procurement Manager's office. These documents will be forwarded, upon request and without charge, to any prospective Bidder.

Each Bid must be on the form prescribed by the Commission and must comply with the terms and conditions set forth in the "Contract Documents."

Each Bid must be accompanied by a Combination Ten Percent (10%) Bid Guaranty Bond/Performance Bond Form covering Fifty Percent (50%) of the estimated Contract value, or a certified check, cashier's check or letter of credit on a solvent bank, payable to the order of the Ohio Turnpike and Infrastructure Commission, in an amount not less than Ten Percent (10%) of the net total amount Bid, adjusted for a twenty (20) day payment term discount, if offered. These Bid Guaranty requirements are in conformance with the Ohio Revised Code Sections 153.54 and 9.312.

If a Combination Bid Guaranty/Performance Bond will be submitted by a Bidder, such bond must be on a form approved by the Commission. Approved bond forms are contained herein. The certified check, cashier's check, letter of credit or Bid Guaranty Bond will be held by the Commission as a guaranty that, if any Bid is accepted, the Contract Documents will be executed and the performance of the Bid secured. Each such check, letter of credit or Bid Guaranty Bond, or the proceeds thereof, will be returned or retained as provided in the General Terms and Conditions.
