

Q#1 All 514 painting items are very specific as to only requiring painting work at the explicitly listed repair areas except for the painting work on Pickel St (sheet 5 of 8) that simply lists "Rocker, Masonry Plate, Anchor Plates, and Any area damaged by contractor's operations"- Can you please verify that this painting work is required at the 8 locations that are called out as a * = Bearing Repair Location?

A#1 At the Pickel Street structure, the Item 514 painting Work is to be performed only at the eight (8) locations designated on Sheet 5 of 8 of the Drawings as " * = Bearing Repair Location".

All Work is to be performed as per the Plans, Specifications, Special Provisions, and other Contract Documents for Bid Invitation No. 4193.
