



ANSWERS TO QUESTIONS RECEIVED THROUGH 1:00 P.M., FEBRUARY 11, 2013

Q#1 Refer to Bid Item 15, 77 each Replace fixed bearing device. When this job was bid the first time this quantity was 43 each. Those same 43 appear in the Re-bid. The re-bid adds Bridge 19.20 with 10 fixed bearings at the abutments under this reference number as shown in the Table on page 66 od 69. This makes the total of 53 fixed bearing on page 66. Where are the other 24 fixed bearings??

A#1 This Rebid of the Project adds not only the structure at Milepost 19.2, but also the structure at Milepost 19.6 to the Work as originally Bid. The Bridge Estimated Quantity Summary on Plan Sheet 2 of 69 provides a breakdown of each quantity by bridge location. For Bid Reference Number 15, SP 516J – Replace Fixed Bearing Device, the total estimated quantity of 77 is the resulting sum of sixteen (16) at Milepost 13.2, seven (7) at Milepost 13.2 RAMP, ten (10) at Milepost 13.4, ten (10) at Milepost 15.1, ten (10) at Milepost 19.2 and twenty-four (24) at Milepost 19.6.

Q#2 Is builder's risk insurance required?

A#2 Builders Risk insurance coverage is not required for 43-12-03.

Q#3 Is there an Excel Bid Form available for this Project?

A#3 There are only thirty-seven (37) bid items on this project. Therefore, due to the brevity of the form, an electronic version of the bid form will not be provided.

Q#4 Plan Sheet 65 of 69 under notes & legend - states to trim beam ends as necessary, and as directed. Can the Commission define the limits/intent of this note? Is this note applicable to all structures or just locations with SP533H Full Depth Joint Replacement? Previous projects have included a Bid Item for SP529 trim ends of structural steel members. Can this Pay Item be added? We feel this item should be quantified by a Bid Item or at least a contingency quantity. Also, is SP 514 applicable to these locations as a result of the trimming?

Q#4 The Note on Sheet 65 of 69 referencing the trimming of beam ends is applicable only to locations where SP 533H Joint Replacement (Bridge Milepost Nos. 10.2, 13.2, 13.2 RAMP, and 13.4) Work is specified, and only is intended if adequate clearance between beam ends is not sufficient to allow for proper thermal movement. During the field investigation for the preparation of the Plans, sufficient clearance existed at these locations. Areas where the paint coatings system is damaged are to be repaired per SP 514A and are included for payment with Item SP 202.
