ANSWERS TO QUESTIONS RECEIVED THROUGH 5:00 P.M., MAY 13, 2013

Q#3 In accordance with SS 848.20 on plan sheet 9/19, the existing bridge deck can be scarified only 1/4" prior to the hydrodemolition operation. We request this 1/4" be increased to 1" to accommodate for the irregularities present on the bridge decks due to the wheel tracks. Also, the limited time these bridge deck can be closed will be difficult to achieve if more of the deck is not scarified due to the slow operation of the hydrodemolition operation. Hydrodemolition of 1" takes a significantly shorter amount of time than removing 1.75". Modifying the scarification depth to 1" will still require 1" of hydrodemolition which is the general accepted depth of minimal removal throughout the construction industry, see ODOT's SS 848.20 which states a minimum of 1" is to be removed by hydrodemolition.

A#3 Addendum No. 3 will be issued to clarify that scarification of one (1) inch will be permitted when performed in accordance with the conditions specified therein.
