Bids are to be submitted in accordance with the Contract Documents prepared by the Commission.

Prevailing Wage Rates and Equal Employment Opportunity requirements are applicable to this Project.

All Bidders entering into a Contract on a Commission-administered Project and their Subcontractors will be required to be enrolled, and in good standing in a “Drug-Free Safety Program” approved by the Ohio Bureau of Workers’ Compensation.

Pollution Liability Insurance is required under GC Art. 12.1.4 for this Project. Builder’s Risk Insurance is not required under GC Art. 12.2 for this Project.

Per the SP 827E, Section A Contractor Prequalification, all Bidders for Contract No. 43-14-02, to be considered, must be included on the Ohio Department of Transportation Pre-Qualified Railroad Track Construction Contractor’s List.

Bids will be received for:

Repair of bridge components, including, but not limited to: patching deteriorated concrete; rehabilitation and/or replacing expansion joints; refurbishing bridge deck; performing concrete weatherproofing; preparation and painting of structural steel, maintenance of traffic; and all other items incidental to the completion of the Work. All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, and other Contract Documents for Project No. 43-14-02.

Bids will be accepted until **May 20, 2014, at 2:00 P.M (E.D.T.)**, when all Bids will be accessed, opened and read aloud. To avoid a potential extension of the Bid Opening date and/or a potential rejection of all Bids, it is imperative that Bidders submit all questions in a timely manner and no later than seven (7) days prior to Bid Opening.
