The Work to be performed under the Contract, if any is awarded on the basis of the Bids, consists of removing and reconstructing 5.90 miles of pavement in the right two (2) westbound lanes and shoulder along the Ohio Turnpike. The Work includes excavating the existing pavement and replacing it with a new pavement section, with alternate Bids being accepted for concrete and asphalt mainline base pavement, and with alternate Bids being accepted for roller compacted concrete and asphalt for the shoulder base pavement. The Work further includes, but is not limited to, two (2) inch mill and fill of the right two lanes of the eastbound roadway, chemically stabilizing the subgrade, making slope repairs, performing drainage repairs and replacements, installing asphalt curbs, guardrail, pavement markings and other traffic control devices, performing temporary traffic control and performing bridge maintenance on six (6) structures. The bridge maintenance Work includes, but is not limited to, repairing the worn surfaces of the bridge decks and abutment slabs, replacing approach slabs, patching concrete, resetting, repairing

and replacing bearings, trimming beam ends, removing and replacing expansion joint armor and associated concrete repairs, removing and replacing expansion joint seals, repairing painting of structural steel and concrete weatherproofing. All Work is to be performed as per the Plans, Specifications, Special Provisions, and other Contract Documents for Contract No. 39-13-01.

Bids will be accepted until **February 5, 2013, at 2:00 P.M (E.S.T.),** when all Bids will be opened and read aloud.
