Construction of containment for, and the removal of, existing lead paint coating; preparation and painting of all structural steel; maintenance of traffic; and all other items incidental to the completion of the Work. All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, and other Contract Documents for Contract No. 40-14-01.

Bids will be accepted until **March 3, 2014, at 2:00 P.M (E.S.T.)**, when all Bids will be accessed, opened and read aloud.
