Sealed Bids will be received by the Ohio Turnpike Commission (“Commission”) at 682 Prospect Street, Berea, Ohio 44017 for the following Project:

Bids are to be submitted in accordance with the Contract Documents prepared by the Commission.

**Prevailing Wage Rates and Equal Employment Opportunity requirements are applicable to this Project.**

**All Bidders entering into a Contract on a Commission-administered Project and their Subcontractors will be required to be enrolled, and in good standing in a “Drug-Free Safety Program” approved by the Ohio Bureau of Workers’ Compensation.**

Bids will be received for:

The Work to be performed under the General Contract that will be awarded consists of structural and electrical Work required to retrofit eight (8) existing toll booths along the Ohio Turnpike in order to install new Automated Toll Payment Machines (“ATPM”). There are two (2) booths to be modified at each of the following Ohio Turnpike Toll Plazas: 52, 91, 152, and 193. Work will consist of modifying the structural steel framing of each booth, and supplying all electrical support required for each ATPM. Each ATPM will have a camera installed in the canopy in the associated lane. The Contractor shall install the wiring and other support equipment required for each camera as shown in the Plans. The Contractor shall be required to remove, replace, modify, and/or relocate various functional items within each toll booth, and complete various incidental items shown in the Drawings to complete this Project. For purposes of this General Contract, the self-performed Work requirement for the Contractor shall be no less than thirty-five (35) percent. All Work is to be performed as per the Plans, Specifications, Special Provisions, and other Contract Documents for Contract No. 64-12-01.

Bids will be accepted until **August 22, 2012, at 2:00 P.M (E.D.T.)**, when all Bids will be opened and read aloud. To avoid a potential extension of the Bid Opening date and/or a potential rejection of all Bids, it is imperative that Bidders submit all questions in a timely manner and no later than seven (7) days prior to Bid Opening.
