Sealed Bids will be received by the Ohio Turnpike Commission (“Commission”) at 682 Prospect Street, Berea, Ohio 44017 for the following Project:

CONTRACT NO. 69-13-02 **OIL/WATER SEPARATOR INSTALLATION

Bids are to be submitted in accordance with the Contract Documents prepared by the Commission.

Prevailing Wage Rates and Equal Employment Opportunity requirements are applicable to this Project.

All Bidders entering into a Contract on a Commission-administered Project and their Subcontractors will be required to be enrolled, and in good standing in a “Drug-Free Safety Program” approved by the Ohio Bureau of Workers’ Compensation.

Bids will be received for:

Installing a precast concrete Oil/Water Separator Vault, a new diversion manhole, twenty-four (24) inch and sixty (60) inch storm sewer pipes and a connection to an existing manhole. The Work will be performed adjacent to a detention pond near the entrance ramp to the Vermilion Valley Service Plaza (Milepost 139.50 eastbound) near Amherst, Ohio. Traffic control, guardrail/fence removal and/or installation, final grading, seeding and mulching will be performed by Ohio Turnpike Commission personnel. All Work is to be performed as per the Plans, Specifications, Special Provisions, and other Contract Documents for Contract No. 69-13-02.

Bids will be accepted until **March 28, 2013, at 2:00 P.M (E.D.T.)**, when all Bids will be opened and read aloud. To avoid a potential extension of the Bid Opening date and/or a potential rejection of all Bids, it is imperative that Bidders submit all questions in a timely manner and no later than seven (7) days prior to Bid Opening.
