ANSWERS TO QUESTIONS RECEIVED THROUGH 12:00 P.M., MAY 16, 2013

- Q#1 The note on sheet 4/5 for pavement fabric states that the fabric shall be installed with a 0.5" leveling Course and tack coat. I do not see a pay item for the leveling course is the cost of this leveling course of asphalt to be included in the cost of the fabric? Also is this 0.5" accounted for in the final elevation of the parking lot, or should the milling depth be 3.5"?
- A#1 The Note referenced on Plan Sheet 4 of 5 is deleted via this Addendum No. 1. No leveling course is required. However, the paving fabric shall be installed in accordance with the SP 629 and the General Note, and any asphalt concrete material required to repair any milled areas will be paid under the applicable asphalt concrete Bid Item.
- Q#2 Sheet 4/5 has a plan note requiring a 0.5" leveling course to be installed with the pavement fabric. Is this leveling course to be installed prior to the placement of the pavement fabric and then the installation of the 1.75" Intermediate Course? If so, what specific asphalt mix is required for the leveling course.
- A#2 See response to Q#1.
- Q#3 The plans call for 448 Type 2 Med. Surface, please confirm this mix specification.
- A#3 Confirmed. Bid Item No. 448 for Asphalt Concrete Surface Course, Type 2 Medium, is the correct type of asphalt surface material to be provided.
- Q#4 The pollution liability insurance requirement is very expensive and we have never bid a project with this requirement before. We is prequalified with ODOT and has successfully completed many road and parking lot reconstruction projects. Can this requirement be deleted from the scope of work?
- A#4 No. Pollution liability insurance is required for this Project.
