Removal by milling of one and three-quarter (1 ³/₄) inches of existing asphalt pavement in the left lane of the mainline and a portion of the median/left shoulder, removal by milling of three and one-half (3 ¹/₂) inches of existing asphalt pavement in the center lane and right lane of the mainline, removal by milling of one and one-quarter (1 ¹/₄) inches of existing asphalt pavement on the right shoulder, mill and fill of the Sonic Nap Alert Pattern ("SNAPs") in the left shoulder (median), resurfacing of the pavement to the thickness specified in the Plans and Notes, repair of median catch basins, concrete weatherproofing of bridges, full depth pavement repairs, installation of raised pavement markers and permanent pavement striping and/or other pavement markings, upgrading of guardrail, installation of SNAPs, asphalt pavement rejuvenation of the median/left shoulder, and temporary traffic control. All Work is to be performed as per the Plans, Specifications, Special Provisions, and other Contract Documents for Contract No. 59-12-05.
