**All Bidders entering into a Contract on a Commission-administered Project and their Subcontractors will be required to be enrolled, and in good standing in a “Drug-Free Safety Program” approved by the Ohio Bureau of Workers’ Compensation.**

Bids will be received for:

The Work to be performed under the Contract, if any is awarded on the basis of the Bids, consists of removal by milling of three and one-quarter (3-1/4) inches of existing asphalt pavement over the concrete pavement, removal by milling of one and one-quarter (1-1/4) inches of existing asphalt shoulder pavement, performing full-depth repairs as specified, resurfacing the pavement and shoulders to the thickness specified, constructing a crossover, refurbishing of crossovers, safety upgrades of guardrail, installing raised pavement markers and pavement striping and/or other pavement markings, installing Sonic Nap Alert Patterns (“SNAPs”), bridge deck and parapet weatherproofing, and temporary traffic control. All Work is to be performed as per the Plans, Specifications, Special Provisions, and other Contract Documents for Contract No. 59-13-01.

Bids will be accepted until **December 21, 2012, at 2:00 P.M (E.S.T.)**, when all Bids will be opened and read aloud. To avoid a potential extension of the Bid Opening date and/or a potential rejection of all Bids, it is imperative that Bidders submit all questions in a timely manner and no later than seven (7) days prior to Bid Opening.
