Q#1 All bid documents are obtained from Bid Express, not from your office, but we need to inform you that we did obtain plans in order to receive any addendums or notices?

A#1 Bidders that have subscribed to Bid Express (monthly or for this Project) will receive notices, Addenda and other communications from the Commission regarding the Project through Bid Express without having to directly request such items from the Commission. See, Articles 1.3.4 and 2.3.2 of the Instructions to Bidders. Bidders that have not subscribed to Bid Express and selected the Project for Bidding may obtain notices, Addenda and other communications from the Commission regarding the Project on the Commission's website, on Bid Express website, or by requesting via e-mail that the Procurement Manager send such communications directly to the Bidder.

Q#2 All required Bid Documents are to be scanned and attached on Bid Express and then all those same forms need to be submitted to OTC no later than 24 hours after the bid opening?

A#2 All submittals required to accompany the Bid Form that are identified in Article 2.7 of the Instructions to Bidders must be scanned and attached to the Bidder's Electronic Bid submitted through Bid Express. Only the original Bid Guaranty, submitted in the form of a combination Bid and Contract Bond, the original Power of Attorney for the Surety's agent, and the original Bidder's Affidavit must be delivered to the Commission no later than 24-hours after Bid Opening. See, Articles 2.7.2 and 6.1.1.1 of the Instructions to Bidders. However, if the Bid Guaranty is submitted in the form of a certified or cashier's check, the original check instrument must be delivered to the Commission's Procurement Manager prior to Bid Opening. See, Articles 2.7.2 and 6.1.1.2 of the Instructions to Bidders. The remaining submittals do not need resubmission after the Bidder submits the scanned copies as attachments to its Bid through Bid Express
