All Bidders entering into a Contract on a Commission-administered Project and their Subcontractors will be required to be enrolled, and in good standing in a “Drug-Free Safety Program” approved by the Ohio Bureau of Workers’ Compensation.

Bids will be received for:

The Work to be performed under the Contract, if any is awarded on the basis of the Bids, consists of removal by milling of two (2) inches of existing asphalt pavement over the concrete pavement, performance of full-depth repairs as specified, resurfacing the pavement to the thickness specified in the Plans and Notes, installation of raised pavement markers and pavement striping and/or other pavement markings, installation of Sonic Nap Alert Patterns (“SNAPs”), and temporary traffic control. Work is to be performed as per the Plans, Specifications, Special Provisions, and other Contract Documents for Contract No. 59-13-02.

Bids will be accepted until **February 4, 2013, at 2:00 P.M (E.S.T.)**, when all Bids will be accessed, opened and read aloud.
