- Q#3 Please refer to Section 10801 part 2.F. A waste receptacle is mentioned, but no make or model is provided and it is not shown on plans. Please provide make, model and quantities for waste receptacle
- A#3 Providing new waste receptacles is not within the Project scope. By way of this Addendum No. 2, the Contract Documents are modified to remove the waste receptacles from the Materials furnished and installed under the Toilet and Bath Accessories component of the Work.
- Q#4 Please refer to Section 10801 part 3 01 C. A soap reservoir system is to be installed, is the reservoir system to be provided with section 10801 Toilet and Bath Accessories or is it provided by others. If it is the responsibility of section 10801, please provide make and model for reservoir system.
- A#4 Providing a new soap reservoir system is not within the Project scope. By way of this Addendum No. 2, the Contract Documents are modified to remove the installation of the soap reservoir system from the Toilet and Bath Accessories component of the Work.

1.05 COORDINATION

- A Coordinate accessory locations with other work to prevent interference with clearances required for access by disabled persons, proper installation, adjustment, operation, cleaning, and servicing of accessories
- B. Deliver inserts and anchoring devices set into concrete or masonry as required to prevent delaying the Work.

1.06 WARRANTY

- A General Warranty: Special warranty specified in this Article shall not deprive the Commission of other rights the Commission may have under other provisions of the Contract Documents and shall be in addition to, and run concurrent with, other warranties made by Contractor under requirements of the Contract Documents.
- B. Manufacturer's Mirror Warranty: Written warranty, executed by mirror manufacturer agreeing to replace mirrors that develop visible silver spoilage defects within minimum warranty period indicated.
 - 1 Minimum Warranty Period: 15 years from date of Substantial Completion

- B. Mirror Glass: ASTM C 1036, Type I, Class 1, Quality q2, nominal 6.0 mm thick, with silvering, electroplated copper coating, and protective organic coating complying with FS DD-M-411.

- C. Galvanized Steel Mounting Devices: ASTM A 153/A 153M, hot-dip galvanized after fabrication
- D Fasteners: Screws, bolts, and other devices of same material as accessory unit, tamper and theft resistant when exposed, and of galvanized steel when concealed
- E. Hand Soap: Pre-diluted liquid coconut oil hand soap for lavatory mounted dispensers.
- F. Waste Receptacles: Polyethylene.

2.03 FABRICATION

- A. General: One, maximum 1-1/2-inch- diameter, unobtrusive stamped manufacturer logo, as approved by Architect, is permitted on exposed face of accessories. On interior surface not exposed to view or back surface of each accessory, provide printed, waterproof label or stamped nameplate indicating manufacturer's name and product model number.
- B. Surface-Mounted Toilet Accessories: Unless otherwise indicated, fabricate units with tight seams and joints, and exposed edges rolled. Hang doors and access panels with continuous stainless-steel hinge. Provide concealed anchorage where possible.
- C. Recessed Toilet Accessories: Unless otherwise indicated, fabricate units of all-welded construction, without mitered corners. Hang doors and access panels with full-length, stainless-steel hinge. Provide anchorage that is fully concealed when unit is closed.
- D. Keys: Provide universal keys for internal access to accessories for servicing and resupplying. Provide minimum of six keys to the Commission's representative

PART 3 - EXECUTION

3.01 INSTALLATION

- A Install accessories according to manufacturers' written instructions, using fasteners appropriate to substrate indicated and recommended by unit manufacturer Install units level, plumb, and firmly anchored in locations and at heights indicated.
- B. Install grab bars to withstand a downward load of at least 250 lbf, when tested according to method in ASTM F 446
 - 1. Provide manufacturer's standard mounting kits and anchoring devices
- C. Install soap reservoir system for lavatory mounted soap dispensers behind chase wall at height indicated. Provide pipe fitting and cap for refilling soap reservoir

3.02 ADJUSTING AND CLEANING

- A Adjust accessories for unencumbered, smooth operation and verify that mechanisms function properly Replace damaged or defective items
- B. Remove temporary labels and protective coatings.
- C. Clean and polish exposed surfaces according to manufacturer's written recommendations.
