Job Duties:

- Maintain, construct, and repair landscaping.
- Apply pesticide treatment of roadside vegetation, ornamentals and turf grass.
- Construction of landscapes.

- Performs snow and ice removal operations when required and any other duties as may be assigned by the Assistant Division Superintendent.

Minimum Qualifications:

- Valid Class "A" Commercial Drivers License (CDL) with a tanker endorsement is required.

- Ohio Commercial Applicator Pesticide License as a minimum, but not limited to Categories 5, 6A and 8, through the Ohio Department of Agriculture Pesticide Regulations is required.

UNUSUAL WORKING CONDITIONS

- Exposure to fumes, dust, dirt, unpleasant odors, vibration, loud noise, hazardous materials, grease, confined work areas, high voltage, power tools, and equipment noise.
- Exposed to changing weather conditions (rain, lightening, humidity, heat, cold, snow, ice);
- Work on extension ladder, manlift and scaffolding.
- Available to work overtime during on-call hours and when necessary, considerable overtime may be required.
