- Monitors toll collection system data through review of daily reports and queries.
- Develops and performs analytical reviews of E-ZPass customer service center system and toll lane operations.
- Inspects, cleanses, transforms, and models toll system data with the goal of discovering useful information, informing conclusions, and supporting decision making.
- Monitors key performance indicators used to assess E-ZPass customer service center system and toll
  collection system operations.
- Develops, prepares, and reviews trending reports.
- Assists with in-lane Automated Toll Payment Machine (ATPM) audits.
- Contributes to the design, implementation, and monitoring of a new tolling system.
- Assists with the comprehensive audit and reconciliation of exit collector and ATPM data.
