### MINUTES OF THE 683<sup>rd</sup> MEETING OF THE OHIO TURNPIKE AND INFRASTRUCTURE COMMISSION MARCH 15, 2021

We are here on video conference – not in person as Amended House Bill 404 effective November 22, 2020, extends the temporary authorization that public bodies received in HB 197 to meet remotely, with an expiration date of July 1, 2021. We are doing our part to help prevent the spread of COVID-19.

**Chairman:** We have a quorum. This is the 683<sup>rd</sup> Meeting of the Ohio Turnpike and Infrastructure Commission. We are holding a meeting today via Microsoft Teams.

As mentioned at the beginning, Amended House Bill 404 effective November 22, 2020, allows us to continue using video conferencing for all public meetings until July 1, 2021. Accordingly, we can check in with our Technology team after the meeting and confirm that this was available by live stream to the public.

Various reports will be received, and we will act on several resolutions. Draft copies have been sent to the Members. The resolutions will be explained during the appropriate reports.

May I have a motion to adopt the Minutes of the February 22, 2021, Commission Meeting? Call the roll, please.

**MOTION:** A motion to adopt the Minutes of January 25, 2021, Commission Meeting was made by Vice Chairman Paradiso and seconded by Chairman Hruby.

**Chairman:** The February 22, 2021 Commission Meeting Minutes are adopted. We will move on with the report of the Secretary-Treasurer, Mrs. Barber.

**Chairman:** Thank you. Any questions or comments regarding the Secretary-Treasurer's report? Hearing none, we will move on to the report from the Executive Director, Ferzan M. Ahmed.

**Director Ahmed:** Thank you, Mr. Chairman. Good morning, Commission Members.

Per the provisions of the Ohio Revised Code, we were invited to testify before the Ohio Senate Transportation Committee on Wednesday, February 24<sup>th</sup>. Due to a family situation, I was unable to appear before the Committee. However, our Director of Government Affairs, Adam Greenslade, represented the Commission and gave testimony on our budget and long-term capital program. He did a great job and I thank him for stepping up. During his testimony, Adam described the modernization of our new Toll Collection System (TCS). Adam advised the Committee Members that we are working with Senator Reineke to advance the legislation needed to go with the new Toll Collection System. I would like to thank Senator Reineke and his staff for their work with the Legislative Service Commission to put our proposed legislative changes into draft form.

The Commission's 2020 Annual Comprehensive Financial Report is under development and includes an Executive Director's year-end review. Some of the highlights of our 2020 accomplishments include:

- Providing essential infrastructure & services during the Pandemic.
- Establishing a public dashboard with key results for performance.
- Beginning construction on the toll collection system modernization project.
- Undertaking of a \$178 million capital improvement program.
- A truck platooning demo on the Ohio Turnpike with the Smart Belt Coalition.
- Dedicating underground railroad historical markers at two service plazas with Governor DeWine.
- Raising \$33,000 for the statewide Combined Charitable Campaign.

March is "Distracted Driving Awareness Month" and we have teamed up with the Ohio State Highway Patrol to launch a "Distracted Driving Enforcement Zone." This initiative started on March 1<sup>st</sup> and will run through the end of the month, across Cuyahoga, Summit and Portage Counties.

The Turnpike Leadership team came together Wednesday, March 3<sup>rd</sup> for our quarterly retreat. There were small group discussions regarding the 2020 Key Results along with a look forward to our initiatives in 2021. There are many opportunities related to innovation and I look forward to seeing this evolve as the year goes on.

I would like to congratulate Tom Stoltz and Len Polash for reaching their career milestones. Tom retired from the Kunkle Maintenance Department February 27<sup>th</sup> and Len retired from the Office Services Department on March 5<sup>th</sup>. I would like to thank them both for their service to the Commission and wish them both the best in retirement.

And finally, in honor of Woman's History Month, we celebrated International Woman's Day on March 8<sup>th</sup> at the Turnpike. We celebrated by dedicating social media posts to the great women that work at the Ohio Turnpike. I would like to thank all of the ladies that represented the Ohio Turnpike as employees and Commission Members in honor of Woman's History Month and International Woman's Day.

Mr. Chairman, this concludes my report, and I will be happy to answer any questions.

Mr. Pakush: Mr. Chairman, I see that Dr. Marchbanks has joined us.

**Dr. Marchbanks:** Yes, Mr. Chairman I am. I have been silent because I am not aware of the protocol in joining a meeting late.

**Chairman:** Myron, thank you for filling in. Dr. Marchbanks will take over from here. We will now move on to the report of the Chief Engineer, Tony Yacobucci.

**Chief Engineer:** Good morning, Mr. Chairman and Commission Members. I have six resolutions for your consideration this morning.

The first resolution for your consideration seeks the Commission's authorization to award Contract No. 46-2021 to Furnish and Apply Retro-Reflective Pavement Markings on the Ohio Turnpike mainline roadway and interchange ramps from Milepost 0.0 to Milepost 241.2. This work is included in the 2021 Operating Budget. On February 24, 2021, Procurement received four (4) bids in response to this Project. The apparent low bid was submitted by American Roadway Logistics ("ARL"), of Norton, Ohio, in the amount of \$1,176,056.40. Commission staff evaluated the unit bid prices and found them to be reasonable and the bid tabulation did not appear to contain any errors or anomalies. The bid submitted by ARL is approximately 5.9% below the Engineer's Estimate of \$1,250,000.00. Based on a review of ARL's Financial Statement and Experience Questionnaire, it appears they have the capacity to perform this work. Although they have not performed this work directly for the Commission in the past, they have satisfactorily performed similar work for the Commission as a subcontractor in the past. Additionally, Engineering Staff has contacted owners for whom ARL had previously performed work, and all reported satisfactory performance. Therefore, it is recommended that the Commission award Contract No. 46-2021 to American Roadway Logistics, of Norton, Ohio, in the amount of \$1,176,056.40. With your permission, may the General Counsel please read the title of the resolution.

**Chief Engineer:** The second resolution for your consideration seeks the Commission's authorization to award Contract No. 43-21-02, for the bridge deck replacement and rehabilitation of the Fangboner Road bridge over the Ohio Turnpike at Milepost 91.1 and the Ohio Turnpike Ramp bridge over the Ohio Turnpike at Milepost 91.6, as well as the removal of the Ohio Turnpike Ramp bridge over State Route 53 and replacing it with a roundabout at Milepost 92.0, all in Sandusky County. This work is included in the 2021 Capital Improvement Budget. On February 19, 2021, Procurement received two (2) bids in response to this Project. The apparent low bid was submitted by Kokosing Construction Company, Inc., of Westerville, Ohio, in the amount of \$4,821,160.90, which is below the Engineers Estimate. This bid was evaluated by both the design consultant, FTC&H, of Toledo, Ohio, as well as Commission staff and was found to contain no errors or anomalies. Kokosing has satisfactorily performed projects of similar scope for the Commission in the past and based on previous years' work volume and work presently under contract, it appears Kokosing has sufficient capacity to perform this project. In addition, Kokosing has committed to meet the 10% SBE goal as set by the Office of Equity and Inclusion. Therefore, it is recommended that the Commission award Contract No. 43-21-02 to Kokosing Construction Company, Inc., of Westerville, Ohio, in the amount of \$4,821,160.90. With your permission, may the General Counsel please read the title of the resolution.

**Dr. Marchbanks:** I have a comment and a question. In regard to the SBEs and Minority and Female owned businesses that the Turnpike works with, the Ohio Department of Transportation would really like to get a comprehensive listing. We are looking at expanding our pool of MBEs and DBEs. We want to make sure that we are aware of all of those people doing work with the Turnpike that are not currently doing work with ODOT, so we can possibly expand our pool of qualified contractors. So, if Chief Engineer Yacobucci and Executive Director Ahmed could forward that information to me I would really appreciate it.

**Chief Engineer:** Mr. Chairman and Dr. Marchbanks, we would be more than happy to provide that information. I will work with Diana Anthony to make sure you get what you need.

**Chairman:** Are there any other questions or comments? Hearing none, please call the roll.

**MOTION:** A motion to adopt *Resolution Approving the Selection of Kokosing Construction Company, Inc. for Project No. 43-21-02 for the Total Amount of \$4,821,160.90* was made by Vice Chairman Paradiso, seconded by Dr. Marchbanks, and approved by all Commission Members present. Resolution No. 13-2021.

**Chairman:** The resolution passes unanimously. Please continue, Tony.

**Chief Engineer:** The third resolution for your consideration seeks the Commission's authorization to award Contract No. 59-21-02 for the Repairs and Resurfacing of the Eastbound and Westbound Mainline Roadway between Milepost 112.45 and Milepost 118.80 in Erie County. This work is included in the 2021 Capital Improvement Budget. On February 23, 2021, Procurement received two (2) bids in response to this Project. The apparent low bid was submitted by the Gerken Paving, Inc., ("Gerken"), of Napoleon, Ohio, in the amount of \$11,742,589.76, which is below the Engineer's Estimate. Commission staff evaluated the unit bid prices and found them to be reasonable and the bid tabulation did not appear to contain any errors or anomalies. Based on a review of Gerken's Financial Statement and Experience Questionnaire it appears they have the capacity to perform this work. They have previously performed similar projects for the Commission in the past with favorable results. In addition, Gerken has committed to exceed the 10% SBE goal as set by the Office of Equity and Inclusion. Therefore, it is recommended that the Commission award Contract No. 59-21-02 to Gerken Paving, Inc., of Napoleon, Ohio, in the amount of \$11,742,589.76. With your permission, may the General Counsel please read the title of the resolution?

**Chairman:** The resolution passes unanimously. Please continue, Tony.

The fourth resolution for your consideration seeks the **Chief Engineer:** Commission's authorization of continuing expenditures for the Contract with Jacobs Engineering Group ("Jacobs"), of Cincinnati, Ohio, for the Modernization of the Toll Collection System. Under Resolution No. 44-2016, the Commission awarded a Contract to Jacobs to perform the services necessary to create a Strategic Plan for the Toll Collection System and Customer Service Center. The Strategic Plan was adopted by the Commission through Resolution No. 57-2017. Subsequently, the Commission exercised the option to assign Task 4 Implementation Services under Resolution Nos. 18-2018, 28-2019 and 37-2019, which included the design of the roadway portion of the new Toll Plaza located at Milepost 211 and the roadway portion of the reconfigured Eastgate Toll Plaza located at Milepost 239. The work also included Environmental, Geotechnical and Site-Civil Design Services for the new and modernized Mainline Toll Plazas at Mileposts 4, 49, 211 and 239. Jacobs has submitted a fee proposal dated January 14, 2021, in the not-to-exceed amount of \$513,042.00, to perform additional Task 4 Final Design Services. The additional services include, but are not limited to, Alta surveys for property acquisition, incorporation of the TCS Integrators solution for the Open Road Tolling slab and gantry, toll canopy demolition plans,

overhead sign structure supports and additional geotechnical and environmental work for EPA and USCOE permitting and wetland mitigation. It should be noted that Jacobs will subcontract \$318,552.00 or 62.1% of these services to DLZ Ohio, Inc., a Commission certified SBE firm. The Engineering staff has reviewed Jacob's proposal and finds it to be reasonable for the scope to be performed. With your permission, may the General Counsel please read the title of the resolution?

**MOTION:** A motion to adopt Resolution Authorizing a Modification to the Agreement with Jacobs Engineering to Perform Additional Task 4 Final Design Services to Implement the Strategic Plan for the Toll Collection System Modernization Project in an Amount Not-to-Exceed \$513,042.00 for a Total Aggregate Contract Amount of \$6,785,355.94 was made by Ms. Eaton Johnson, seconded by Secretary-Treasurer Barber, and approved by all Commission Members present. Resolution No. 15-2021.

**Chairman:** The resolution passes unanimously. Please continue, Tony.

**Chief Engineer:** The next two resolutions for your consideration seeks the Commission's authorization for the purchase of sixteen (16) single-axle snow and ice trucks, with the cab and chassis of the trucks being purchased under the Ohio Department of Transportation's ("ODOT's") Cooperative Purchasing Program Contract Number 023-21 and the dump bodies, plows, hydraulics, lighting systems, and grease system purchased under the Ohio Department of Administrative Services Cooperative Purchasing Program, State Term Contract Index No. STS515, Schedule No. 800860. The purchase of the snow and ice trucks is included in the 2021 Capital Budget and is required to complete the replacement of existing 2009 model year snow and ice trucks. The cab and chassis for the sixteen (16) snow and ice trucks is available for acquisition under ODOT's Cooperative Purchasing Program from Valley Freightliner & Western Star, Inc., of Parma, Ohio, in the amount of \$1,647,632.00, and the snow and ice truck dump bodies, plows, hydraulics, lighting systems, and grease system are available for acquisition under the Ohio Department of Administrative Services Cooperative Purchasing Program from Concord Road Equipment Manufacturing, Inc., of Painesville, Ohio, in the amount of \$2,296,156.18. The total combined cost for the sixteen (16) snow and ice trucks will be \$3,943,788.18. In addition, the existing 2009 model year snow and ice trucks shall be disposed of in accordance with the Commission's Property Disposal Policy after the new snow and ice trucks are placed into service. With your permission, may the General Counsel please read the title of each resolution?

**Chairman:** The resolution passes unanimously. Please continue, Jennifer.

**General Counsel:** The second resolution is a Resolution Authorizing the Purchase of Sixteen Snow and Ice Truck Bodies from Concord Road Equipment Manufacturing, Inc. in the Total Amount of \$2,296,156.18 Under the DAS Cooperative Purchasing Program.

**Chairman:** Any questions or comments? Hearing none, please call the roll.

**MOTION:** A motion to adopt The second resolution is a *Resolution Authorizing the Purchase of Sixteen Snow and Ice Truck Bodies from Concord Road Equipment Manufacturing, Inc. in the Total Amount of \$2,296,156.18 Under the DAS Cooperative Purchasing Program was made by Chairman Hruby, seconded by Dr. Marchbanks, and approved by all Commission Members present. Resolution No. 17-2021.* 

**Chairman:** The resolution passes unanimously. Is there anything further Mr. Yacobucci.

**Chief Engineer:** No, Mr. Chairman. That completes my report.

**Chairman:** Thank you for your work. We will move on next to the CFO/Comptroller/Deputy Executive Director, Marty Seekely.

**CFO/Comptroller/DED:** Thank you, Mr. Chairman. I have a brief update on our traffic and revenue for the month of February.

This first chart shows the monthly passenger car miles traveled on the Ohio Turnpike over the past two years.

Passenger car vehicle miles traveled were down 22.8% in February as a result of the effect of COVID-19, an increase in the number of days of snow in February this year, and the extra day in February last year because of leap year .

If you subtract February 29<sup>th</sup> from last year's total, passenger car vehicle miles traveled were down 19.2% this year.

However, commercial traffic continued to increase and was up 4.8% in February. If you exclude February 29<sup>th</sup> from last year's total, then commercial traffic was up 7.3% from last February.

The decrease in passenger car traffic combined with the toll rate increase on January 1 caused passenger car toll revenue to decrease 21.4% in February from the same month last year. If you remove February 29<sup>th</sup> from last year, passenger car toll revenue is down 17.6% from February of last year.

The increase in commercial traffic combined with the toll rate increase caused commercial vehicle toll revenues to increase 6.5% in February. If you remove February 29<sup>th</sup> from last year, commercial vehicle toll revenue is up 9.0% from February of last year.

This chart shows the weekly percentage change in total toll revenue from the corresponding week of last year. Since the major decline in April of last year, the change from last year has steadily improved. More recently, toll revenues were up 6.5% week ending February 27<sup>th</sup> and up 6.9% week ending March 6<sup>th</sup>. Last week, which is not on the chart, toll revenue was up 8.0% from last year.

This chart shows year-to-date toll revenues through the month of February during each year over the past decade. Year-to-date total toll revenues were \$104,000 or 0.2% above the amount from last year. If you subtract February 29th from last year's total, total toll revenues are up \$729,000 or 1.7% over last year.

That completes my report, Mr. Chairman.

**Chairman:** Thank you, Marty. Any questions or comments? Hearing none, we will now move on to the report of our General Counsel, Jennifer Stueber.

**General Counsel:** Chairman, I am going to reserve my report for Executive Session, please.

**Chairman:** Thank you, Jennifer. We will move on to the report of the Ohio State Highway Patrol, Staff Lieutenant William Haymaker.

**Staff Lieutenant Haymaker:** Good morning, Mr. Chairman and Commission Members.

On February 24, 2021, at 1900 hours, Trooper J. D. Cross, Unit 170, stopped a 2016 Dodge Durango for a speed violation of 99 mph on IR 80 Ohio Turnpike near MP 190. Trooper A. G. Sliwoski, Unit 1422, arrived on scene for a probable cause search of the vehicle. After the driver and front seat passenger exited the vehicle, the rear seat passenger climbed into the driver's seat and fled the scene eastbound in the vehicle. Trooper Sliwoski pursued the vehicle eastbound. The suspect exited the Turnpike at exit 209 and struck the guardrail. The suspect then traveled for a short time westbound on SR 5 before he stopped and fled on foot. Trooper Sliwoski caught the suspect and took him into custody without further incident. The pursuit traversed approximately 19 miles and reached speeds up to 125 MPH.

On February 25, 2021, at approximately 1926 hours, Trooper Lash U-856 of the Milan Post, stopped a 2010 red Chevrolet Camaro for multiple marked lanes violations near milepost 127

in Erie County. While interacting with the driver, Trooper Lash suspected that the driver, Mr. Kendrick D. Price of Cleveland, Ohio, was under the influence of alcohol. Concluding standard field sobriety tests, Trooper Lash subsequently arrested the driver for OVI. During the Administrative Inventory of the vehicle, Trooper McMillen found just over two pounds of raw marijuana in the vehicle. Mr. Price was charged with F3 - marijuana possession, OVI, drug paraphernalia possession marked land and distracted driving.

Every time someone takes their eyes off the road – even for just a few seconds – they put their lives and the lives of others in danger. That's why the Ohio Turnpike and the Ohio State Highway Patrol launched a distracted driving safety initiative along a nearly 30-mile stretch of the Ohio Turnpike. This initiative began on March 1 and will end on Wednesday, March 31.

The section is being designated as a Distracted Driving Enforcement Zone and will span across Cuyahoga, Summit and Portage counties. Motorists will see an increased presence of troopers and additional electronic signage within this zone in an effort to reduce crashes and raise awareness. Statewide, from 2019 through 2020, there were 24,489 crashes involving distracted driving. Of those, 8,654 were injury crashes and 70 were fatal crashes.

Distracted driving is any non-driving activity with the potential to distract a person from the primary task of driving and increase the risk of crashing. Distractions can be visual, taking eyes off of the road; manual, taking hands off the wheel; or cognitive, taking the mind off the driving task. Texting while driving is an example that results in all three types of distraction.

That completes the report of the Ohio State Highway Patrol, Mr. Chairman.

**Chairman:** Any questions for Staff Lieutenant Haymaker? Thank you again for the service of yourself and the men and women of the Ohio State Highway Patrol.

It is 10:42 a.m. and I move that we hold an Executive Session to discuss confidential matters under the provisions of Ohio Revised Code Section 121.22(G)(5). At the end of such Executive Session, the Commission shall resume its open meeting.

**10:42 a.m. - MOTION:** A motion to adjourn into Executive Session was made by Chairman Hruby, seconded by Vice Chairman Paradiso, and approved by all Commission Members present.

**Chairman:** I move that we conclude the Executive Session pursuant to the provisions of Ohio Revised Code Section 121.22(G)(5) and resume the open meeting of the Commission.

**Chairman:** It is 12:07 p.m. and we are adjourned from Executive and will resume the Commission Meeting.
