# **RESOLUTION NO. 24-2011**

### Resolution Authorizing the Interim Executive Director to Enter into an Agreement with Ohio Edison Company for Electric Service to The Mahoning Valley and Glacier Hills Service Plazas

WHEREAS, Section 5537.04(10) of the Ohio Revised Code provides that the Commission may make or enter into all contracts and agreements necessary to the performance of its duties and the execution of its powers; and

WHEREAS, Section 5537.28 of the Revised Code authorizes the Commission to use toll revenues for the purpose of making infrastructure improvements to existing service plaza facilities in order to carry out its duties, powers and functions; and

WHEREAS, on January 24, 2011, the Commission adopted Resolution No. 1-2011 awarding Contracts to rebuild the Mahoning Valley and Glacier Hills Service Plazas located in Mahoning County; and

WHEREAS, the expenditures by the Commission to provide for the construction of necessary infrastructure improvements to upgrade and relocate electric utility service to the Mahoning Valley and Glacier Hills Service Plazas will exceed \$150,000.00, and, therefore, in accordance with Article V, Section 1.00 of the Commission's Code of Bylaws, Commission action is necessary to enter into such agreement; and

WHEREAS, the Ohio Edison Company has offered to construct the necessary infrastructure improvements in order to upgrade and relocate electric service to the Mahoning Valley and Glacier Hills Service Plazas in the amount of \$214,594.82 under terms and conditions that are mutually acceptable to both the Utility and the Commission; and

WHEREAS, the Commission has duly considered such recommendations.

NOW, THEREFORE, BE IT

RESOLVED that the Interim Executive Director and the General Counsel are hereby authorized to execute an agreement with the Ohio Edison Company for the purpose of upgrading and relocating electric service to the Mahoning Valley and Glacier Hills Service Plazas, which agreement includes the Commission reimbursing the Ohio Edison Company for those infrastructure improvements necessary to provide such service; and

FURTHER RESOLVED, the Interim Executive Director and General Counsel are authorized to take any and all actions necessary to carry out the terms of said agreement.

**Chairman:** Thank you, any questions for the Chief Engineer? Thank you, CFO/Comptroller.

CFO/Comptroller: Good morning Mr. Chairman and Commission Members. I have one resolution for your consideration. In your materials is a resolution authorizing the Interim Executive Director to enter into a contract for depository and various other banking services. On March 28th, the Commission issued a request for proposals for banking services for an initial contract term of three years, with two optional two-year extensions. The major banking service requested by the Commission is the processing of the daily cash and coin deposits from our toll plazas, other services include such things as accounts payable and payroll checking accounts, escrow accounts, payroll direct deposit, purchasing cards, ACH transactions, wire transfers, lockbox, and other miscellaneous banking services. A mandatory pre-proposal conference was held April 5<sup>th</sup>; ten banking institutions attended this conference, and four proposals were opened on April 25<sup>th</sup>. The cost and technical merits of each proposal were separately evaluated. The Evaluation Team comprised of the Accounting Manager, Director of Audit and Internal Control, and I conducted the technical review of the proposals without being informed of their respective costs. As needed the Director of Contracts Administration served as facilitator. As a result of this review FirstMerit Bank was judged to have the highest technical score by the Evaluation Team. The Purchasing Manager separately evaluated the projected cost and revenues of each proposal. JP Morgan Chase did not quote vault services as a percentage of cash deposited as

required in the RFP, making their cost proposal difficult to compare to the other proposals. Of the three banks who quoted the vault services as required in the RFP; FirstMerit Bank had the lowest projected annual fees. The Commission also invests a substantial portion of its funds in overnight sweep investments with its depository bank. FirstMerit Bank's proposed investment rates for the sweep accounts would provide the highest investment revenue of the four proposals Based on the proposed banking fees and projected investment revenues, the submitted. Purchasing Manager determined that FirstMerit's proposal generated \$70,575 more net revenue per year than the next best proposal. In summary, FirstMerit's proposal received the highest technical score, had the lowest cost for banking fees, and it would pay the Commission the highest revenue on its invested funds. Based on the outcome of the process I have described and by virtue of FirstMerit's continued outstanding performance under the bank's existing contract with the Commission, the Evaluation Team recommends that FirstMerit Bank be designated as the Commission's depository under a new contract for banking services as outlined in the RFP for the next three years, commencing July 1, 2011, with two optional two-year extensions. With your permission Mr. Chairman, I'd like to ask the General Counsel to please read the Resolved.

### **RESOLUTION NO. 25-2011**

# Resolution Authorizing the Interim Executive Director to Enter into a Contract with a "Designated Depository" to Furnish Various Banking Services to the Commission

WHEREAS, on March 28, 2011, the Commission issued its Request for Proposals ("RFP") for Banking Services for an initial contract term of three (3) years, which may be extended for two, additional two-year periods; and

WHEREAS, copies of the Commission's RFP were mailed to thirteen banking institutions expressing an interest in providing the requested banking services to the Commission and, on April 25, 2011, four banks submitted Proposals in response to the RFP; and

WHEREAS, inasmuch as expenditures under the Banking Services Contract will exceed \$150,000.00, in accordance with Article V, Section 1.00 of the Commission's Code of Bylaws, Commission action is necessary for the award of said Contract; and

WHEREAS, an Evaluation Team comprised of the CFO/Comptroller, the Accounting Manager, and the Director of Audit and Internal Control conducted the Technical review of the Proposals submitted and awarded a Technical Score to each Proposal; and

WHEREAS, after the Evaluation Team awarded the Technical Scores, the Commission's Purchasing Manager tabulated the Cost Proposals, and determined the Cost Proposal Score for each respondent, with **FirstMerit Bank** of **Cleveland Ohio** receiving both the highest Technical Score and the highest Cost Proposal Score; and

WHEREAS, based on the overall scores, the Evaluation Team has concluded that **FirstMerit Bank** has proposed the best combination of value and price to the Commission in response to the subject RFP, and further recognizes FirstMerit's outstanding service under its existing contract with the Commission as demonstrative of this bank's qualifications and abilities to satisfactorily perform all of its obligations pursuant to its Proposal; and

WHEREAS, the Commission's Director of Contracts Administration has reviewed the Evaluation Team's recommendation, as reflected in her written recommendation, which is before the Commission, and she has communicated her agreement to the Interim Executive Director and the Commission; and

WHEREAS, the Commission has been further advised by its Director of Contracts Administration that the aforesaid Proposals were solicited on the basis of the same specifications, terms and conditions with respect to all respondents and potential respondents, that the procedures followed conform to the requirements of Ohio Revised Code Section 5537.07 relative to the award of professional service contracts, that FirstMerit Bank has provided a proposal guaranty and evidence of its ability to provide all other required bonds and insurance as set forth in the RFP, and that the Commission may legally enter into a contract with FirstMerit Bank; and

WHEREAS, the Interim Executive Director has made his recommendation to the Commission predicated on the Evaluation Team and the Director of Contracts Administration's recommendations; and

WHEREAS, the Commission has duly considered said recommendations.

### NOW, THEREFORE, BE IT

**CFO/Comptroller:** Yes, I have an update on our traffic and revenue for the month of April. This first chart shows the monthly passenger car miles traveled on the Ohio Turnpike over the past two years. We continue to feel the effects of the recent increase in the cost of gas, as passenger car vehicle traveled decreased in April and were 2.5% less than last year. The increase in commercial traffic that we had been experiencing moderated in April as commercial vehicle miles traveled were only .8% higher than last year. This chart shows year-to-date vehicle miles traveled through April for each year over the past decade. Year-to-date passenger car miles are 1% lower than last year, while year-to-date commercial miles are 3.3% higher than last year. Total year-to-date vehicle miles traveled combined with an increase in the percentage of E-ZPass use caused passenger car toll revenues to decline 4.7% in April compared to last year. Toll revenues from commercial vehicles were up 1% from April of last year. Total toll revenues in April declined \$299,000 or 1.6% from last year and this was the first time in the last year that total toll revenues were less than the prior year.
