**Chairman:** Thank you. Before we move to the resolution I would just like to officially welcome Adam Greenslade to the Commission. He was recently appointed, he is from the Sandusky area, and his background is in heavy and economic development, part of Team ACOG. He is very familiar with the Turnpike transportation and of course the importance of economic development. **General Counsel:** Mr. Chairman, Commission Members I have one proposed resolution for your consideration this morning. The resolution would authorize the appointment of Richard A. Hodges to the position of Executive Director of the Commission. As you are aware, the Chief Engineer Daniel F. Castrigano has served as the Interim Executive Director of the Commission since April 1<sup>st</sup>, 2011, and it should be noted that he has provided exemplary service to the Commission not only in this capacity, but in his 30 years continuous service to the Commission in various capacities. Mr. Hodges has been recommended by the Chairman for appointment to the position of Executive Director to serve at the pleasure of the Commission and in accordance with Article V, Section 1.00 of the Commission's Code of Bylaws dated March 17, 2003. Pursuant to Article I, Section 2.00 of the Commission's Code of Bylaws the Chairman of the Commission is authorized to establish the compensation and terms and conditions of the employment of the Executive Director and the proposed resolution would authorize the Chairman to execute all documents necessary to employ Richard A. Hodges as the Executive Director and to establish his compensation. In addition, the Commission has previously established by Resolution Number 3-2003 that the position of Executive Director should be exempt from those provisions of the Employee Manual that govern vacation leave, personal leave, and sick leave. Finally it has been the prior practice of the Commission that the Executive Director serve in the position of Assistant Secretary-Treasurer as established in the Commission's Code of Bylaws and the proposed resolution continues this practice by authorizing the appointment of Richard Hodges to the position of Assistant Secretary-Treasurer. With your permission Mr. Chairman I will read the Resolved.

# Chairman: Please.

**General Counsel:** I apologize Mr. Chairman I did misread the first paragraph with respect to the effective date of the appointment.

Chairman:No problem. Is there a second to the resolution?Mr. Pakush:I second the resolution.Chairman:First of all the motion.Mr. Pakush:Okay I am sorry. I thought there was motion.Chairman:And I'll second it.

Second. Discussion? Anyone wish to say anything about this? I would. Chairman: Let me speak for just a moment here. Richard, I have gotten to know him in a short period of time. He is currently the Director of Legislative Development and Operational Reform with the Ohio Bureau of Workers' Compensation in Columbus, Ohio. He is a graduate of the University of Toledo, has his Masters Degree in Public Administration, he had his B.A. in Government and a minor in History. Graduated originally from Oberlin College and then got his Masters at the University of Toledo. He served as Treasurer of Fulton County, he served as Director for a variety of organizations, served the State Legislature, State Representative from 1993 to 1999 and during that period of time he served on the Ohio Turnpike Commission and is very familiar with the goings and comings of the Turnpike Commission. He has been very active in economic development in the State of Ohio and in other states, he has held the position of Executive Vice-President and a Contractor's Association and Chief Executive Officer in Tucson in a realtor's association and then Executive Director in Milwaukee, Wisconsin for a Metropolitan Builders' Association, so he comes with a good background in a variety of things that are integral to the operations of the Ohio Turnpike and we are very, very pleased to make this recommendation to the Commission, making Richard Hodges our new Executive Director.
