- Destination **Ohio Turnpike Toll Plaza 232 (I-76) West** is on the **Right**

## Diversion Notes

- Close Ohio Turnpike (I-80/I-90) Westbound at Toll Plaza 239 exit ramp.
- LCVs cannot use diversion route. Depending on the estimated duration of closure LCVs can wait in place or U-turn at Toll Plaza 239. Check with Toll Plaza to make sure space is available to U-turn an LCV.
- If either Toll Plaza is unstaffed then consider staffing during diversion to reduce traffic queue / wait times.
- During a prolonged closure or major incident the County EMA may be able to provide water, blankets, gasoline, food, etc. for entrapped motorists.
- The County EMA may be able to provide four wheelers, generators, PCMBs, power tools, etc. to help manage and/or clear the incident area.

## Ramp Closures

- If incident is after Toll Plaza 239 Westbound entrance ramp then close Toll Plaza 239 Westbound entrance ramp.
- If incident is after Mahoning Valley Service Plaza (milepost 237.2) entrance ramp then close Service Plaza entrance ramp.
- Depending on duration of closure consider allowing passenger vehicles trapped at the Service Plaza to use the Service Plaza Access Gate diversion.
- Diversion route should be driven to make sure there are no obstructions, weather related issues, local detours, etc.



