## Primary Diversion Route

- Exit Ohio Turnpike (I-76) West at Milepost 239.0
- Turn Left onto E Pine Lake Road West (0.4 mi.)
- Turn Left onto New Castle Road West (2.1 mi.)
- Turn Right onto SR 165 West (2.5 mi.)
- Turn Left onto SR 165 West (1.2 mi.)
- Turn Right onto SR 7 North (1.4 mi.)
- Destination Ohio Turnpike Toll Plaza 232 (I-76) West is on the Right

## Alternate Diversion Route

- Exit Ohio Turnpike (I-76) West at Milepost 239.0
- Turn Left onto E Pine Lake Road West (0.4 mi.)
- Turn Left onto New Castle Road West (0.3 mi.)
- Turn **Right** onto **Unity Road North** (0.9 mi.)
- Turn Left onto E South Range Road West (1.0 mi.)
- Turn **Right** onto **Beard Road North** (3.1 mi.)
- Turn Left onto E Western Reserve Road West (3.5 mi.)
- Turn Left onto SR 7 South (1.3 mi.)
- Destination Ohio Turnpike Toll Plaza 232 (I-76) West is on the Right

- Diversion route is for passenger vehicle use only.
- Diversion route should be driven to make sure there are no obstructions, weather related issues, local detours, etc.
- Removal of entrapped commercial vehicles will depend on the expected duration of the closure.
- If Toll Plaza is unstaffed then consider staffing during diversion to reduce traffic queue / wait times.
- During a prolonged closure or major incident the County EMA may be able to provide water, blankets, gasoline, food, etc. for entrapped motorists.
- The County EMA may be able to provide four wheelers, generators, PCMBs, power tools, etc. to help manage and/or clear the incident area.
