Bids are to be submitted in accordance with the Contract Documents prepared by the Commission.

Prevailing Wage Rates and Equal Employment Opportunity requirements apply to this Project.

The Small Business Enterprise (DBE/EDGE/SBE) Goal applicable to this Project is 10%.

Pollution Liability Insurance is required under GC Art. 12.1.4 for this Project. Builder’s Risk Insurance is not required under GC Art. 12.2.1 for this Project.

Bids will be received for Project No. 39-20-02 (Part A & Part B), which includes the following:

The Work to be performed under the Contract for Project No. 39-20-02 (PART A), if any is awarded on the basis of the Bids, consists of removing and reconstructing the pavement in the right two (2) lanes and shoulder in both directions of the Ohio Turnpike. The Work includes, but is not limited to, excavating existing pavement, constructing full depth pavement, chemically stabilizing the subgrade, constructing approach and departure ramp pavement for new plaza in both directions, performing slope repairs, performing drainage repairs and replacements, installing concrete barrier wall, asphalt curbs, guardrail, performing approach slab replacements, pavement markings and other traffic control devices, performing temporary traffic control, tree removal, clearing and grubbing, right of way fence replacement, installation of new ramp light foundations, light poles, pull boxes and coordination with the 58-20-01 Building Contractor and the Toll Collection Systems Integrator Contractor.

The Work to be performed under the Contract for Project No. 39-20-02 (PART B), if any is awarded on the basis of the Bids, consists of but not limited to, site demolition of previous Service Plaza appurtenances, excavating existing pavement, excavating and constructing embankment for grading preparation of the entire toll plaza site, performing drainage installations, reconstruction and new construction of access drives, construction of asphalt curbs, guard rail installation, constructing full depth asphalt pavement, installation of pavement markings and other traffic control devices on both the north and south side of the Ohio Turnpike.

All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, Technical Specifications, and other Contract Documents for Project No. 39-20-02 (Part A & Part B).

Bids will be accepted until **January 27, 2020, at 2:00 P.M. (Eastern Time)**, when all Bids will be accessed, opened and read aloud. Bidders should submit all questions no later than seven (7) days prior to Bid Opening.
