ANSWERS TO QUESTIONS RECEIVED THROUGH 2:00 P.M. ON MARCH 20, 2020:

Q#1 Will the bid opening still be as scheduled? Asking due to COVID-19 situation.

A#1 The Commission is required by law to conduct bid openings in public. Therefore, a public bid opening will take place at the Commission's Administration Building as scheduled on March 25, 2020 at 2:00 P.M. (Eastern Time). After the bid opening, a bid tabulation will be posted on the Commission's website by the end of business on Wednesday, March 25, 2020.

Q#2 Will notary stamp be required due to limitations of staff from COVID-19?

A#2 Due to the issues related to COVID-19, a notary stamp on the Non-Collusion Affidavit is optional. However, please be advised that the successful bidder, if one is selected, will be required to submit a fully signed and notarized Non-Collusion Affidavit prior to the issuance of a purchase order.

Q#3 Is a bid bond required for this bid?

A#3 No. Please refer to the Notice to Bidders which states: "PLEASE NOTE, A BID GUARANTY/PERFORMANCE BOND IS NOT REQUIRED FOR THIS BID INVITATION."

Q#4 Is the elevator maintenance bid still going to be due on the 25th? I'm assuming it wouldn't be a public bid opening due to the virus concerns. Is there any thoughts to extend the bid a couple weeks?

A#4 The bid opening date will not be extended. Bids are due by 2:00 P.M. (Eastern Time) on Wednesday, March 25, 2020 and, as required by law, will be opened in public. See A#1 above.
