ANSWERS TO QUESTIONS RECEIVED THROUGH 1:00 P.M. ON MAY 7, 2021:

- Q#9 Concerning the 451 10" reinforced concrete pavement detail as shown on Drawing B20. Please provide spacing for the #7 epoxy coated rebar. Also clarify which bar is required a #4 or # 6 bar, and the required spacing for this bar. Please provide detail if these bars are to over lapped or are they to be spaced within the contraction basket joint plan
- A#9 The No. 7 epoxy coated rebar, as shown on Plan Sheet B20, shall be spaced 6" center on center. The No. 4 bar, as shown on Plan Sheet B20, shall be spaced at 18" center on center within the limits of the island. The No. 6 bar, as shown on Plan Sheet B20, shall be spaced at 12" center on center outside the limits of the island. On Plan Sheet B20, the triangle symbol that is shown under the bar in the detail represents a support for the bars and do not represent a dowel basket. The bars shall not overlap the contraction joint baskets.

Q#10 Will you accept our umbrella policy to combine with the general liability and automobile liability in order to comply with the limits you are requesting?

A#10 The Commission will accept an umbrella policy to combine with the general liability insurance and automobile liability insurance to comply with the required limits. See Article 12, Section 12.1.2 of the General Conditions in the form of Contract which reads as follows: "A Commercial General Liability policy and Commercial Automobile Liability policy to provide insurance and limits as indicated below. An Umbrella or Excess Liability policy may be used to attain such limits."
