Sealed Bids will be received by the Ohio Turnpike and Infrastructure Commission (“Commission”) from Bidders subscribing to Bid Express (<https://www.bidexpress.com>) and selecting the following Project for Bidding:

Bids are to be submitted in accordance with the Contract Documents prepared by the Commission.

Prevailing Wage Rates and Equal Employment Opportunity requirements apply to this Project.

The Small Business Enterprise (DBE/EDGE/SBE) Goal applicable to this Project is 10%.

Pollution Liability Insurance is required under GC Art. 12.1.4 for this Project. Builder’s Risk Insurance is not required under GC Art. 12.2.1 for this Project.

Bids will be received for Project No. 59-20-01, which includes the following:

Removal by milling of three (3) inches of existing asphalt pavement in the center and right lanes of the mainline, removal by milling of two (2) inches of existing asphalt in the left lane and left and right shoulders, mill and fill of the Sonic Nap Alert Pattern (“SNAPs”) in the left and right shoulders, resurfacing of the pavement and shoulders to the thickness specified in the Drawings, concrete approach slab removal and replacement, patching of concrete bridge decks, concrete weatherproofing of bridges, full depth pavement repairs, installation of raised pavement markers and permanent pavement striping and/or other pavement markings, upgrading of guardrail, installation of SNAPs, and temporary traffic control, in both Eastbound and Westbound lanes. All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, Technical Specifications, and other Contract Documents for Project No. 59-20-01.

Bids will be accepted until **December 23, 2019, at 2:00 P.M. (Eastern Time)**, when all Bids will be accessed, opened and read aloud. Bidders should submit all questions no later than seven (7) days prior to Bid Opening.
