Bids are to be submitted in accordance with the Contract Documents prepared by the Commission.

Prevailing Wage Rates and Equal Employment Opportunity requirements apply to this Project.

The Small Business Enterprise (DBE/EDGE/SBE) Goal applicable to this Project is 10%.

Pollution Liability Insurance is required under GC Art. 12.1.4 for this Project. Builder’s Risk Insurance is not required under GC Art. 12.2.1 for this Project.

Bids will be received for Project No. 59-20-03, which includes the following:

Excavation and full depth shoulder reconstruction as specified in the Drawings, removal by milling of three and one-half (3 1/2) inches of existing asphalt pavement on the interchange pavement and shoulders, mill and fill of the Sonic Nap Alert Pattern (“SNAPs”) in the right shoulder along the mainline pavement, resurfacing of the interchange pavement and shoulders to the thickness specified in the Drawings, installation of raised pavement markers and permanent pavement striping and/or other pavement markings, upgrading of guardrail, installation of SNAPs, and temporary traffic control. All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, Technical Specifications, and other Contract Documents for Project No. 59-20-03.

Bids will be accepted until **March 24, 2020, at 2:00 P.M. (Eastern Time)**, when all Bids will be accessed, opened and read aloud. Bidders should submit all questions no later than seven (7) days prior to Bid Opening.
