Pollution Liability Insurance is required under GC Art. 12.1.4 for this Project. Builder’s Risk Insurance is not required under GC Art. 12.2.1 for this Project.

Bids will be received for Project No. 70-20-01, which includes the following:

Slope repairs requiring installation of a haul road or other access to the work area; removal of loose material; benching, placing and compacting embankment material; installing, re-installing, replacing and modification of various drainage infrastructure components; installing rock channel protection; performing general sediment and erosion control to protect the project from weather events that may occur within the locality of the project; restoration of the site; seeding and mulching; temporary traffic control; and all other items incidental to the completion of the work. All Work is to be performed as per the Plans, Drawings, Specifications, Special Provisions, Technical Specifications, and other Contract Documents for Project No. 70-20-01.
