ANSWERS TO OUESTIONS RECEIVED THROUGH 3 P.M. ON JULY 24, 2023:

Q#1 Our dilemma is that it clearly states under the items listed "Failure to submit a bid for all Items shall invalidate the bid."

As steel blades and rubber blades are very different, would you still consider a bid if there is no bid for the rubber blades? Or is this bid an all or nothing bid?

A#1 A bidder must submit a bid for all Items within a Group, a Bidder may submit a response to one (1) or more Groups. An award will be made, if any award be made, to the bidder determined to be the lowest responsive and responsible bidder for each Group. If a bidder is determined to be the lowest responsive and responsible bidder for more than one (1) Group, all such Groups will be included in a single award.

To be considered for Award, Bidders must bid on all Items within a Group.

Part 5 (Page 5-1), Part 6 (Page 6-3) and Part 8 (Page 8-2) of the Bid Invitation have been revised and are included with this Addendum No. 1.

Bids are solicited herein, for furnishing Snow Plow Blades for use on Commission owned snow and ice trucks. Bids shall be in strict compliance with the requirements of the Specifications and the other Contract Documents.

The bidder must submit a bid in response to all Items. An award will be made, if any award be made, to the bidder determined to be the lowest and best for one or all items. Failure to submit a bid for all Items within the group shall invalidate the bid.

A bidder must submit a bid for all Items within a Group, a Bidder may submit a response to one (1) or more Groups. An award will be made, if any award be made, to the bidder determined to be the lowest and best for each Group. If a bidder is determined to be the lowest and best for more than one (1) Group, all such Groups will be included in a single award.

To be considered for Award, Bidders must bid on all Items within a Group.

The Commission reserves the right to reject all Bids and to waive minor technical defects or irregularities.

Bidders are to complete all of the following forms attached hereto and submit them with their Bids.

PART 8

SPECIAL PROVISIONS

Data to be Submitted by Bidder:

Snow Plows Blades shall be provided in accordance with the attached Specifications. The Bidder shall submit with their bid, the manufacturer's technical and descriptive data covering their proposed item to be furnished under the Specifications. Each package shall be labeled, with complete identification of the product and manufacturer.

The descriptive data to be submitted with each Bid shall be used in evaluating Bids. This data, however, will not be considered part of the Bid and will not authorize the furnishing of material not meeting the Specifications.

The Commission may, but shall not be obligated to, disregard any misdescription of any detail of the material contained in the Bidder's Bid, on determining, that said detail has in fact been inadvertently or otherwise erroneously described or set forth. In such case, the Commission may accept or reject the Bid on the basis of the correct information concerning the materials offered therein.

Delivery:

The delivery of snow plow blades shall be completed sixty (60) days following the issuance of Purchase Authorization.

The Vendor shall not make delivery or cause delivery to be made at any time other than normal weekday working hours, Monday through Friday, between the hours of 8:00 A.M. and 3:00 P.M., exclusive of holidays. Contact for Elmore Delivery will be Jeffrey Landel, Division I Superintendent. Contact for Hiram delivery will be Matthew McMullen, Division II Superintendent.

The Commission assumes no obligation or responsibility to the Vendor with regard to the use of rear access delivery routes. It is the responsibility of the Vendor to keep informed at all times during the period of the Purchase Authorization of availability of rear access routing.

If in the event it is necessary to use the Turnpike to complete delivery, the Vendor shall be required to pay the regular toll fee. No exceptions will be made.

Method of Payment:

For payment purposes, the Contractor shall prepare and submit to the Commission's Accounts Payable, 682 Prospect Street, Berea, Ohio 44017, an original copy of invoice for services at each individual location. Invoices consolidating items contained on two (2) or more locations are unacceptable and cannot be honored for payment. Invoices may be submitted electronically to the following e-mail address: apinvoicing@ohioturnpike.org

Insurance:

Immediately upon the execution of the Contract, the Selected Contractor shall forward to the Commission certificates of insurance which show that the Selected Contractor is insured by an insurance company or companies rated A- or better by A.M. Best and approved by the Commission. Said insurance shall be maintained in full force and effect until the Contract has been fully and completely performed. It shall protect the Selected Contractor and the Commission from liability and claims for damages for bodily injury, including wrongful death, personal and advertising liability and for damages to property caused by an accident arising from the Selected Contractor's performance of the Contract. Said insurance shall provide that in the event of cancellation or expiration of the policy, a thirty (30) day advance notice thereof will be given to the Ohio Turnpike and Infrastructure Commission.

The Selected Contractor shall purchase and maintain Commercial General Liability Insurance, for liability and claims for damages for bodily injury, including wrongful death, personal and advertising liability and for damages to property caused by an accident, including employer's liability, in an amount not less than \$1,000,000 per occurrence, \$1,000,000 general aggregate. Coverage shall be on an occurrence form and include contractual liability

The Selected Contractor shall, at its own expense, also purchase and maintain Commercial Automobile Liability Insurance covering liability arising out of the ownership, maintenance or use of all owned, non-owned, and hired automobiles including mobile equipment in an amount of not less than a Combined Single Limit of \$1,000,000 for Bodily Injury and Property Damage.

The Ohio Turnpike and Infrastructure Commission shall be endorsed as an additional insured on the Commercial General Liability and Commercial Automobile Liability policy or policies. The insurance policy or policies shall be primary and non-contributory. The above-described certificates of insurance shall be delivered to and remain in the custody of the Commission and each shall be in form and words satisfactory to the Commission

.

The Selected Contractor shall also procure and maintain until the Contract has been fully and completely performed, Ohio Worker's Compensation Insurance covering all employees who engage in any work in connection with the performance of the Contract except employees hired in a state other than Ohio who will not engage in any work in the State of Ohio.

The Commission may, at any time, require the Selected Contractor to obtain any additional or other insurance. In each such case, the Commission shall reimburse the Selected Contractor for the net premium cost thereof which reimbursement shall be made at the time of final payment.
