**ANSWERS TO QUESTIONS RECEIVED THROUGH 12:00 P.M. ON SEPTEMBER 8, 2021:**

**Q#1 I would like to request the construction documents (Construction Plans, Specifications and any other relevant documents) for the three projects identified, Project Nos. 58-21-01, 58-21-02 and 58-22-01.**

*A#1 The construction documents for Project Nos. 58-21-01 and 58-21-02 are available to send via FTP link to interested respondents upon receipt of a request submitted to purchasing@ohioturnpike.org. The construction documents for Project No. 58-22-01 are not complete and will not be complete until after a contract is awarded under this Request for LOIs.*

**Q#2 Could you please tell me if there will be one professional services contract awarded for LOI NO. 12-2021? Or, will there be one firm retained for each project identified?**

*A#2 The Commission anticipates selecting one consultant to award one contract to perform the architectural/engineering services for all three construction projects – Project Nos. 58-21-01, 58-21-02 and 58-22-01.*

**Q#3 And, will Project Nos. 58-21-01, 58-21-02 and 58-22-01 bid as one job or separately?**

*A#3 Project Nos. 58-21-01, 58-21-02 and 58-22-01 will be bid separately. The Commission has already awarded contracts for Project Nos. 58-21-01 and 58-21-02 pursuant to Resolution Nos. 24-2021 and 47-2021, respectively. Copies of resolutions are available on the Commission's website.*

**Q#4 On page 2. Item number 3. It mentions the proposed Project Manager must be a professional engineer registered in the State of Ohio. My question is if this project is mostly architectural is it okay to have the Project Manager be a registered Architect instead of a PE?**

*A#4 Yes, a Registered Architect is acceptable.*

**Q#5 I have been asked by a A/E firm to be their EDGE/WBE consultant for the above referenced project. we did notice on the form, Part III, item 2 lists that you have to have a statement of quals for the Ohio Turnpike on file. I do not have that, but I'm a registered WBE/EDGE consultant through the State of Ohio DAS. Also, I'd be a subconsultant to a firm that does have their quals on file.**

**Am I acceptable to team with them?**

*A#5 The requirement to have a Statement of Qualifications on file with the Commission only applies to an A/E firm which will serve as a prime consultant. In regard to a subconsultant teaming with an A/E firm and meeting the SBE project goal, businesses certified as an EDGE Business Enterprise by the Ohio Department of Administrative Services will receive recognition from the Commission as a DBE or SBE through a “fast track” application after verification of the certification with the Ohio Department of Administrative Services.
