**ANSWERS TO QUESTIONS RECEIVED THROUGH 12:00 P.M. ON SEPTEMBER 3, 2025:**

**Q#1 The Scope states: “Conduct investigations and file reports with local, state, and federal agencies as necessary to gain environmental approval for the project.” Could you clarify what the Commission envisions for environmental approvals?**

*A#1 The Commission envisions a cursory review for potential jurisdictional wetlands within the project limits and any necessary permit requirements to be completed through USACE along with a Section 404 Pre-Construction Notice package and subsequent Section 404 Nationwide Permit. A mussel survey may need to be completed as well. Coordination with USFWS for any potential endangered species concerns. Coordination with OHPO for any potential impacts to historic structures or archaeological resources. Any further environmental approvals can be discussed during a final scoping meeting with the selected consultant.*

**Q#2 Is there federal funding associated with this project?**

*A#2 There are no federal funds associated with this project.*

**Q#3 Environmental Approvals - Is the intent to follow the ODOT Categorical Exclusion (CE) process?**

*A#3 See A#1.*

**Q#4 Is the environmental review limited to asbestos/lead paint only?**

*A#4 No, see A#1. An asbestos survey and testing for lead based paints shall be completed for the both bridges as part of the preliminary investigation and inspection of the structures.*
