## ANSWERS TO QUESTIONS RECEIVED THROUGH 5:00 P.M. ON OCTOBER 9, 2025:

- Q#1 Resume Content Requirements: No. 3 "Resumes should include the qualifications of the key staff, descriptions of work performed on similar projects, which must include name of project Owner, a project number, the month/year timeframe duration of listed project work experience along with the name of listed work experience supervisor, relevant certifications and year they were obtained." Could you please clarify whether the "supervisor" referenced should be the internal supervisor (i.e., within the submitting firm) or the Client/Owner's representative for the listed project?
- A#1 The listed work experience supervisor refers to the direct reporting manager of the firm or Owner the person was working with at the time. Examples: for OTIC experience, the Resident Engineer or the firm Project Manager (for Resident Engineer) in charge of that project, for ODOT experience, the ODOT Project Engineer in charge of that project.
- Q#2 Resume Content Requirements: Regarding the "project number", can you confirm that this refers to the Owner's project number, rather than an internal tracking number used by the submitting firm?
- A#2 The Project Number refers to the Owner's Project Number.
- Q#3 Submission Scope: Is it acceptable to submit a LOI for only one of the two listed projects, or is the Commission expecting a response that addresses both projects together?
- A#3 Yes, a respondent can choose one or both projects to respond to. Please refer to LOI instructions Part III. and Part VII. for more information.
