#### ANSWERS TO QUESTIONS RECEIVED THROUGH 8:00 A.M. ON MARCH 21, 2022:

- Q#10 Initial order is scheduled for deliveries, beginning 4/18/22, just 4 weeks after the closing date on the bid, not to mention the actual date of award. Current lead time for this paper is 3 months, with another 3 month lead time for production, plus in transit time; how should we proceed?
- A#10 The Commission is not able to extend the bid opening date. See response to Q#9. We will take into consideration the tight schedule from award to delivery; however, we cannot accommodate a 3 month delay.
- Q#11 With samples (500 of each ticket), required upon submission of the bid, there will be an additional charge required, for production and we would require an extension of the bid. Will this be acceptable?
- A#11 The Commission will not absorb costs related to sample test tickets. The Commission is not able to extend the bid opening date. See response to Q#9.

#### Q#12 Will these tickets be cut or burst; if burst, what is the burst strength specification?

- *A#12* The tickets will be cut. The BOCA Lemur printer uses an integrated auto cut mechanism to cut the thermal fan fold tickets at the perforation.
- Q#13 I am working on this bid and we had to order tooling for this and I was just informed that we won't be able to have it before March 24<sup>th</sup>. Is there any way to send in the samples once we receive the tooling?
- *A#13* No. See response to *Q#8*. Sample Tickets are due on March 24, 2022 (Bid Due Date) by 5:00 P.M. Eastern Time.

# Q#14 If a bid extension is granted, may the sample tickets be sent, by the awarded vendor, after the contract is awarded?

A#14 No. See response to Q#9. The Commission is not able to extend the bid opening date. See response to Q#8. Sample Tickets are due on March 24, 2022 (Bid Due Date) by 5:00 P.M. Eastern Time.
